Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, is seeking administrative approval of a nonstandard spacing and proration unit (“NSP”) for its Mule 23-11 Fed Com 623H, 713H, 733H, 624H, 714H, and 734H (API Nos. 30-015-Pending), gas wells, covering a 720-acre, to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying the N/2 NE/4 of Section 23 and the E/2 of Sections 14 and 11, Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico. C-102s for the Wells are attached as Exhibit D. These are horizontal wells that will be drilled as follows:

Mule 23-11 Fed Com 623H Well:

- Surface Location (SL): 959’ from the North line and 2,097’ from the East line of Section 23, Township 25 South, Range 31 East;

Devon has included as Exhibit C, a letter explaining why this application is needed. These wells will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish a 320-acre spacing unit, comprised of 160-acre, quarter section building blocks.

The nonstandard spacing unit will be comprised of the N/2 NE/4 of Section 23 and the E/2 of Sections 14 and 11, Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico, and therefore notice was provided to affected persons that are excluded from the standard horizontal spacing unit, pursuant to 19.15.16.15B(5)(b). Excluded lands include the S/2 NE/4 of Section 23, Township 25 South, Range 31 East.

Devon attests that, on or before submission of this application, it provided notice to the affected persons in the S/2 NE/4 of Section 23, Township 25 South, Range 31 East; said notice as described satisfies all provisions of NMAC 19.15.15.11B(4) and NMAC 19.15.16.15B(5)(b); copies of the application and required plat maps were furnished. Devon also provided notice to the Bureau of Land Management to the extent that they own interest with respect to excluded areas of the proposed nonstandard unit. Additionally, Devon obtained an NSP waiver agreement from Mewbourne Oil Company, whose operating interests are in the S/2 NE/4 of Section 23. Devon provides herein a sectional map of this area showing the proposed nonstandard unit and the standard unit, attached as Exhibit E. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit F. The development plan for this unit is pursuant to a Joint Operating Agreement; therefore, there is no associated pooling case number. Devon has recently submitted NSL Applications for each of the wells, 623H, 713H, 733H, 624H, 714H, and 734H, located within the nonstandard unit.


