Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, is seeking administrative approval of a unorthodox well location (“NSL”) for its Mule 23-11 Fed Com 711H (API Nos. 30-015-Pending), gas well, covering 720-acres, to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying the N/2 NW/4 of Section 23 and the W/2 of Sections 14 and 11, Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit D. This is a horizontal well that will be drilled as follows:

Mule 23-11 Fed Com 711H Well:

- Surface Location (SL): 771’ from the North line and 637’ from the West line of Section 23, Township 25 South, Range 31 East;
- Bottom Hole Location (BHL): 20’ from the North line and 990’ from the West line of Section 11, Township 25 South, Range 31 East;
- First Take Point (FTP): 1,216’ from the North line and 990’ from the West line of Section 23, Township 25 South, Range 31 East;
- Last Take Point (LTP): 100’ from the North line and 990’ from the West line of Section 11, Township 25 South, Range 31 East.

Devon has included as Exhibit C, a letter explaining why this application is needed. The well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330' setback requirements. The completed interval for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox well location will encroach towards the S/2 NW/4 of Section 23 and the SW/4 of Section 2, Township 25 South, Range 31 East.

Devon attests that, on or before submission of this application, it provided notice to the affected persons in the adjoining S/2 NW/4 of Section 23 and the SW/4 of Section 2, Township 25 South, Range 31 East; said notice as described satisfies all provisions of NMAC 19.15.4.12A(2)(a) and NMAC 19.15.15.13D; copies of the application and required plat maps were furnished. Devon also provided notice to the Bureau of Land Management to the extent that they own interest with respect to areas adjoining the proposed unorthodox well location unit. Additionally, Devon obtained an NSL waiver agreement from Mewbourne Oil Company, whose operating interests are in the S/2 N/2 of Section 23. Devon provides herein a tract map outlining the unorthodox HSU with affected area tracts identified, attached as Exhibit E. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit F. The development plan for this unit is pursuant to a Joint Operating Agreement; therefore, there is no associated pooling case number.

Devon Energy Production Company, L.P. respectfully requests administrative approval of a non-standard location ("NSL") for each of the Mule Wells referenced above. The Mule Wells are in the Purple Sage-Wolfcamp Gas Pool (Pool Code 98220). It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last take point from three hundred and thirty feet (330') to one hundred feet (100') will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.


