19.15.34.13.C. "A recycling containment shall be deemed to have ceased operations if less than 20% of the total fluid capacity is used every six months following the first withdrawal of produced water for use. The operator must report cessation of operations to the

appropriate division district office. The appropriate division district office may grant an extension to this determination of cessation of operations not to exceed six months".

The recycling clock for the monthly reports hasn't yet started, but according to the conditions of approval, the five-year period of operation began on September 30, 2020:

"The 1RF-457 RODNEY ROBINSON AST CONTAINMENT is approved for five years of operation from the date of permit application. OCD received the permit application on September 30, 2020. The 1RF-457 RODNEY ROBINSON AST CONTAINMENT permit expires on September 30, 2025. If Solaris wishes to extend operations past five years, an annual permit extension request must be submitted using an OCD form C-147 through the OCD Online system by May 9, 2025."
