Devon Energy Production Company, L.P., ("Devon"), OGRID No. 6137, is seeking administrative approval of an unorthodox well location ("NSL") for its EXMOOR 10-34 Fed Com 714H (API No. 30-015-Pending), gas well, covering 960-acres, to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying the E/2 of Sections 10 and 3, Township 25 South, Range 31 East, and the E/2 of Section 34, Township 24 South, Range 31 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit D. This is a horizontal well that will be drilled as follows:

**EXMOOR 10-34 Fed Com 714H Well:**

- Surface Location (SL): 515' from the North line and 664' from the East line of Section 15, Township 25 South, Range 31 East;
- Bottom Hole Location (BHL): 20' from the North line and 990' from the East line of Section 34, Township 24 South, Range 31 East;
- First Take Point (FTP): 100' from the South line and 990' from the East line of Section 10, Township 25 South, Range 31 East;
- Last Take Point (LTP): 100' from the North line and 990' from the East line of Section 34, Township 24 South, Range 31 East.

Devon has included as Exhibit C, a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330' setback requirements. The completed interval for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox well location will encroach towards the NE/4 of Section 15, Township 25 South, Range 31 East, and the SE/4 of Section 27, Township 24 South, Range 31 East.

Devon attests that, on or before submission of this application, it provided notice to the affected persons in the adjoining unit that includes the adjacent NE/4 of Section 15, Township 25 South, Range 31 East, and the adjacent SE/4 of Section 27, Township 24 South, Range 31 East; said notice as described satisfies all provisions of NMAC 19.15.4.12A(2)(a) and NMAC 19.15.15.13D; copies of the application and required plat maps were furnished. Devon also provided notice to the Bureau of Land Management to the extent that they own interest with respect to areas adjoining the proposed unorthodox well location unit. Devon provides herein a tract map outlining the unit location of the unorthodox well with affected area tracts identified, attached as Exhibit E. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit F. The development plan for this unit is pursuant to a Joint Operating Agreement; therefore, there is no associated pooling case number.

Devon Energy Production Company, L.P. respectfully requests administrative approval of a non-standard location ("NSL") for each of the EXMOOR Wells referenced above. The EXMOOR Wells are in the Purple Sage-Wolfcamp Gas Pool (Pool Code 98220). It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last take point from three hundred and thirty feet (330') to one hundred feet (100') will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.

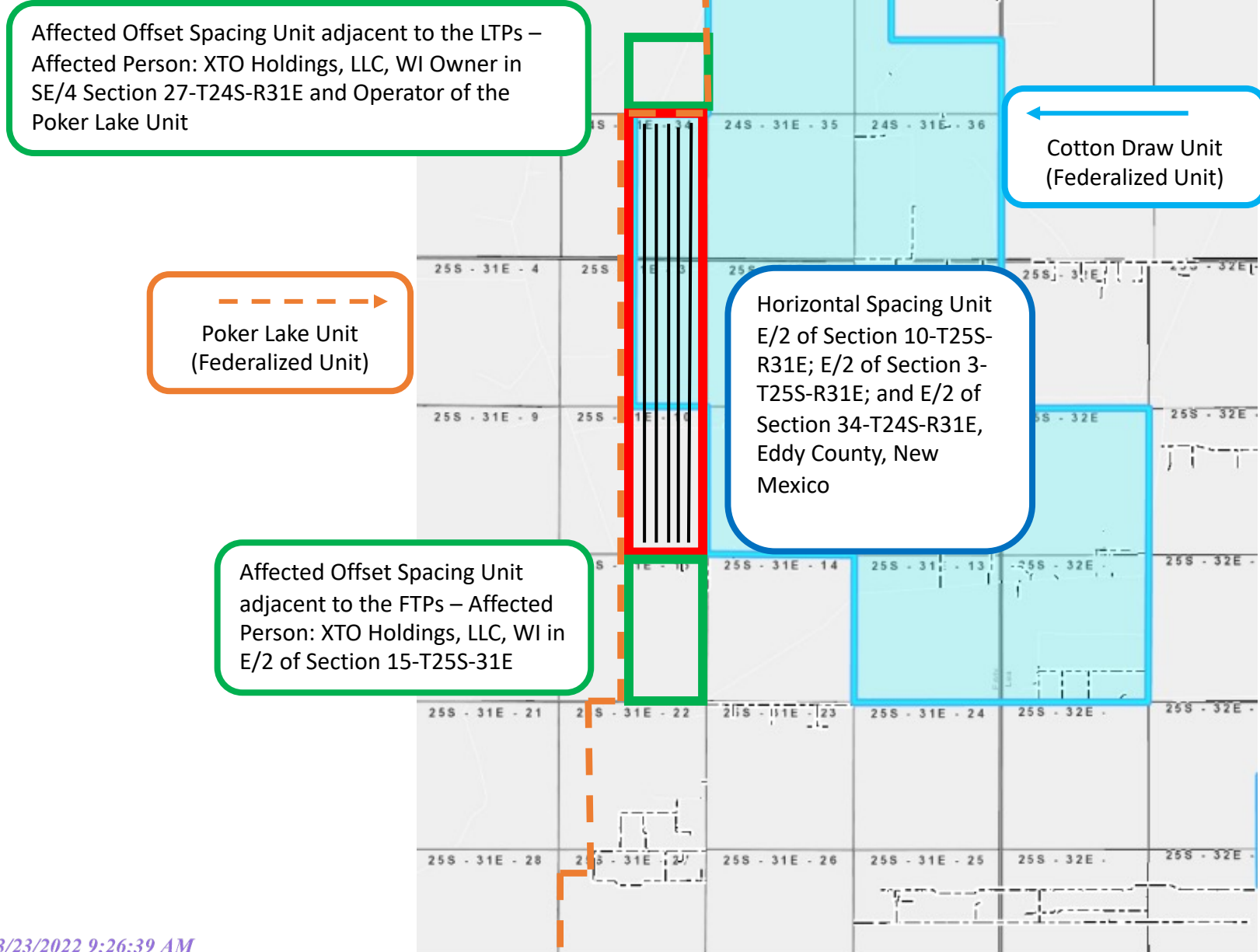
