Dear Ms. Sandoval:

Pursuant to 19.15.16.15(B)(5) NMAC, COG Operating LLC ("COG")(OGRID 229137) seeks administrative approval of a 960-acre non-standard horizontal spacing unit comprised of Section 20 and the N/2 of 29, Township 25 South, Range 35 East, NMPM, Lea County, New Mexico. The proposed non-standard spacing unit will be dedicated to the **Green Beret Fed Com 602H, 702H, 703H and 704H, 705H, 801H and 802H** that will develop the Wolfcamp formation (Dogie Draw Wolfcamp Pool 17980).

Division Rules authorize administrative approval of non-standard spacing units to prevent waste and protect correlative rights in conformance with 19.15.15.11(B) NMAC. COG seeks approval of this non-standard spacing unit to allow for one surface production facility, reduce surface disturbance and eliminate the need for commingling (i.e. one communitized area). Approval also will allow for a well density design that leads to the most effective and efficient development of this area.

Exhibit A is a copy of the Well Location and Acreage Dedication Plat (C-102) for each of the wells drilled within the proposed non-standard spacing unit.

Exhibit B is a map showing the wells and the proposed non-standard spacing unit in Section 20 and the N/2 of Section 29. The map also shows the tracts affected by this request.

Exhibit C is a list of the affected parties that were provided a copy of this application with all attachments, by certified mail, and advising them that if they have an objection it must be filed in writing with the Division within 20 days from the date the Division receives the application. The Bureau of Land Management was also provided a copy of the application. Proof of mailing and a copy of the notice letter is attached as **Exhibit D**.
