Tap Rock Operating, LLC (OGRID No. 372043), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13(C)-(D) NMAC and applicable rules governing acreage and well location requirements for the Purple Sage; Wolfcamp (Gas) pool [98220], seeks administrative approval of an unorthodox well location for its **Cypress 33 Fed Com # 213H well** (API No. 30-015-47860), in a 320-acre, more or less, spacing unit underlying the E/2 of Section 33, Township 23 South, Range 29 East, N.M.P.M., Eddy County, New Mexico.

The proposed surface and bottom hole locations and first and last take points are as follows:

- the surface location is located 11 feet from the north line and 1444 feet from the east line (Unit B) of Section 33,
- the bottom hole location is located 30 feet from the south line and 2589 feet from the east line (Unit O) of Section 33,
- the first take point is located 100 feet from the north line and 2589 feet from the east line (Unit B) of Section 33 and

- the last take point is located 100 feet from the south line and 2589 feet from the east line (Unit O) of Section 33.

Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because the first and last take points are closer (100 feet instead of 330 feet as to the north and south boundaries, and 67 and 58 feet instead of 330 feet as to the western boundary) than the standard offsets to the northern, southern, and western boundaries of the spacing unit – thus encroaching on (1) the SW/4 and W/2 SE/4 of Section 28, Township 23 South, Range 29 East, (2) the N/2 of Section 4, Township 24 South, Range 29 East, and (3) the W/2 of Section 33, Township 23 South, Range 29 East. Approval of the unorthodox, completed interval will increase the well's effective lateral length by 460 feet, and the E/W location of the lateral allows for more effective draining of the reservoir when viewed in conjunction with the spacing pattern for the wells in the W/2 of Section 33 – thereby increasing ultimate recovery of reserves and preventing waste of natural resources.

Exhibit A is a Form C-102 with attached plats showing (1) the first take point of the proposed Cypress 33 Fed Com # 213H well encroaches on the spacing unit/tracts to the north in the SW/4 and W/2 SE/4 of Section 28, Township 23 South, Range 29 East, and encroaches on the spacing unit/tracts to the west in the W/2 of Section 33, Township 23 South, Range 29 East, and (2) the last take point of the well encroaches on the spacing unit/tracts to the south in the N/2 of Section 4, Township 24 South, Range 29 East, and encroaches on the spacing unit/tracts to the west in the W/2 of Section 33, Township 23 South, Range 29 East.

Exhibit B is a plat for the E/2 of Section 33, Township 23 South, Range 29 East, the SW/4 and W/2 SE/4 of Section 28, Township 23 South, Range 29 East, and the N/2 of Section 4, Township 24 South, Range 29 East, and W/2 of Section 33, Township 23 South, Range 29 East, that shows the proposed Cypress 33 Fed Com # 213H well in relation to adjoining spacing unit/tracts to the north, south, and west. OXY USA Inc. is the operator of wells in the affected spacing units to the north and south (Tap Rock is 100% owner/operator of wells in the spacing unit to the west). The United States owns the mineral estate or a part thereof in each of the affected spacing units. Accordingly, the "affected persons"¹ are OXY USA Inc. and the United States Bureau of Land Management. Included as **Exhibit C** is a waiver from OXY USA Inc. Therefore, notice only needs to be provided to the United States Bureau of Land Management.

Exhibit D is a spreadsheet listing all affected persons and includes tracking information demonstrating that each of the affected persons has either executed a waiver or was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 
