Devon Energy Production Company, L.P. (OGRID No. 6137), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13(C)-(D) NMAC and applicable rules governing acreage and well location requirements for the WC-025 G-08 S243217P; UPR Wolfcamp pool [98248], seeks administrative approval of an unorthodox well location for its **Right Meow 31-6 Fed Com 716H well** (API No. 30-025-48460), in a 320-acre, more or less, spacing unit underlying the E/2 E/2 of Section 31, Township 23 South, Range 32 East and E/2 E/2 of Section 6, Township 24 South, Range 32 East, N.M.P.M., Lea County, New Mexico.

The proposed surface and bottom hole locations and first and last take points are as follows:

- the <u>surface location</u> is located 350 feet from the north line and 1155 feet from the east line (Unit A) of Section 31,
- the <u>bottom hole location</u> is located 110 feet from the south line and 1091 feet from the east line (Unit P) of Section 6,

- the <u>first take point</u> is located 413 feet from the north line and 1065 feet from the east line (Unit A) of Section 31 and
- the <u>last take point</u> is located 139 feet from the south line and 1091 feet from the east line (Unit P) of Section 6.

Additionally, as shown by Exhibit A, some steering difficulties were encountered resulting in portions of the completed interval for this well extending as close as 223 feet from the western boundary of the spacing unit (see Unit A of Section 6).

Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because certain portions are closer (223 feet instead of 330 feet) than the standard offsets to the western boundary of the spacing unit – thus encroaching on the W/2 E/2 of Section 31, Township 23 South, Range 32 East, and W/2 E/2 of Section 6, W/2 NE/4 of Section 7, Township 24 South, Range 32 East. Approval of the unorthodox, completed interval will allow Devon to use its preferred well spacing plan for horizontal wells in this area and thereby maximize recovery and prevent waste.

**Exhibit A** is a Form C-102 showing the completed interval of the proposed Right Meow 31-6 Fed Com 716H well encroaches on the tracts to the west in the W/2 E/2 of Section 31, Township 23 South, Range 32 East, and W/2 E/2 of Section 6, Township 24 South, Range 32 East.

**Exhibit B** is a plat for Section 31, Township 23 South, Range 32 East and Sections 6 and 7, Township 24 South, Range 32 East, that shows the proposed Right Meow 31-6 Fed Com 716H well in relation to adjoining spacing units to the west. Devon is the operator of a well in the affected spacing unit to the west. However, Javelina Partners also owns a working interest (as to the W/2 NE/4 of Section 7). Additionally, the United States owns the mineral estate or a part thereof in the affected spacing unit. Accordingly, the "affected persons" <sup>1</sup> are Javelina Partners and the United States Bureau of Land Management.

**Exhibit** C is a spreadsheet listing all affected persons and includes tracking information demonstrating that each of the affected persons has either executed a waiver or was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 


