Advance Energy Partners Hat Mesa, LLC (OGRID No. 372417) request administrative approval for a nonstandard location (NSL) for the proposed Wool Head 20 State Com 553H (30-025-46471), located in a 240-acre horizontal spacing unit in the W2SE of Section 17 and W2E2 of Section 20, Township 21 South, Range 33 East, Lea County, New Mexico.

The proposed surface and bottom hole locations and first and last take points are as follows:

- The surface location is located 350 feet from the south line and 2,079 feet from the east line (Unit O) of Section 20,
- The bottom hole location is located 2,540 feet from the south line and 2,310 feet from the east line (Unit J) of Section 17
- The first take point is located 726 feet from the south line and 2,434 feet from the east line (Unit O) of Section 20,
- The last take point is located 2,316 feet from the south line and 2,310 feet from the east line (Unit J) of Section 17.

The Wool Head 20 State Com 553H (30-025-46471) is an oil well located in WC-025 G-08 S213304D; Bone Spring pool [97895].

Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because the first take point is closer than the standard offsets to the western boundary of the spacing unit and encroaches on the E2SW of Section 17 and E2W2 of Section 20, Township 21 South, Range 33 East, Lea County, New Mexico. Approval of the NSL will allow Advance to use its preferred well spacing for horizontal wells in this area and thereby maximize recovery and prevent waste.

**Exhibit A** is a Form C-102 showing the completed interval of the Wool Head 20 State Com 553H well which encroaches on the spacing unit/tracts to the west in the E2W2 of Sections 17 and 20.

**Exhibit B** is a plat for Sections 17 and 20 that shows the Wool Head 20 State Com 553H well in relation to the adjoining spacing unit/tracts to the west. As shown on the plat, the affected spacing unit to the west


is operated by Advance Energy Partners Hat Mesa and governed by an operating agreement between Advance and The Allar Company (Allar). A notification letter has been sent to Allar and Allar provided its non-objection to the NSL application. 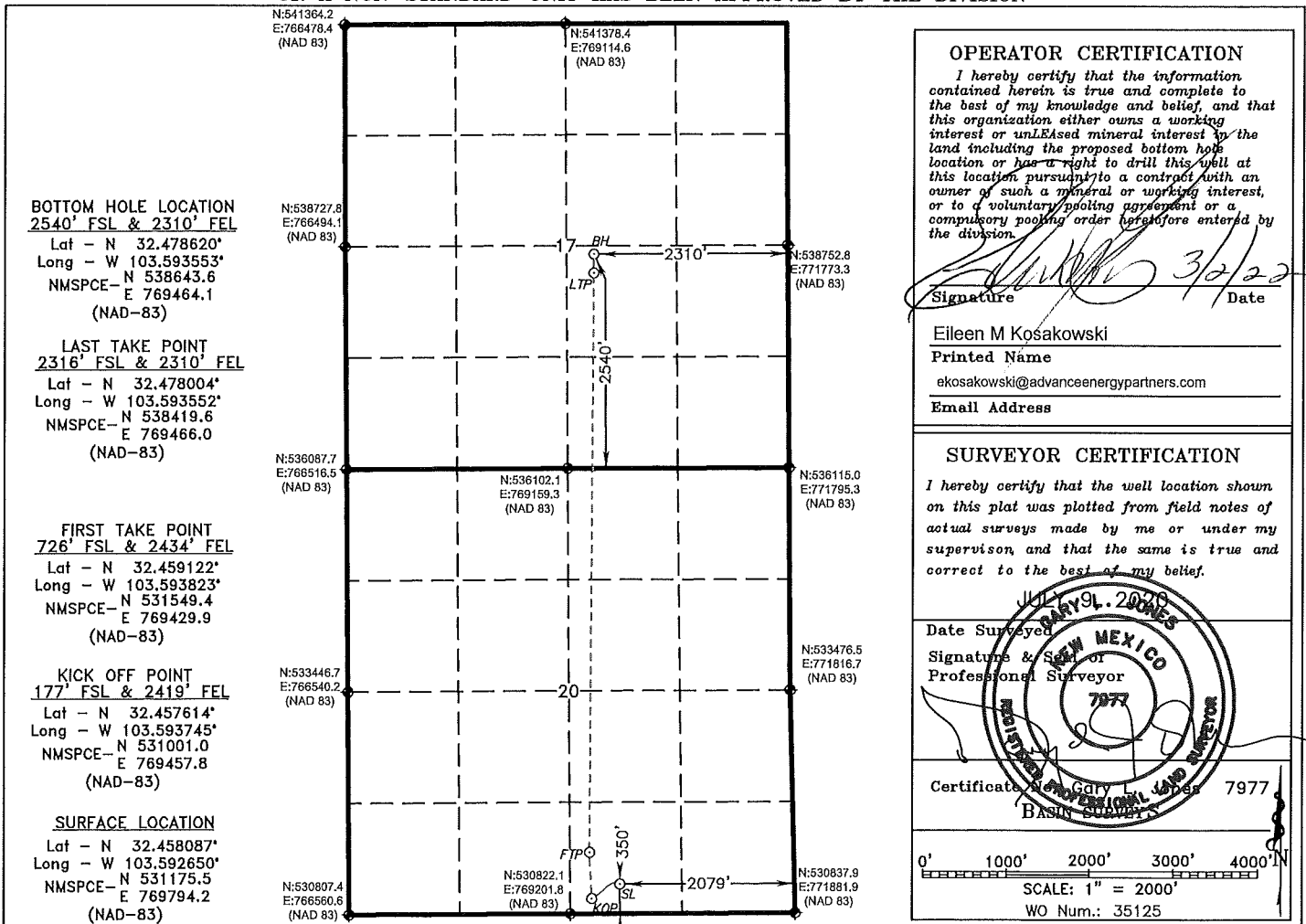

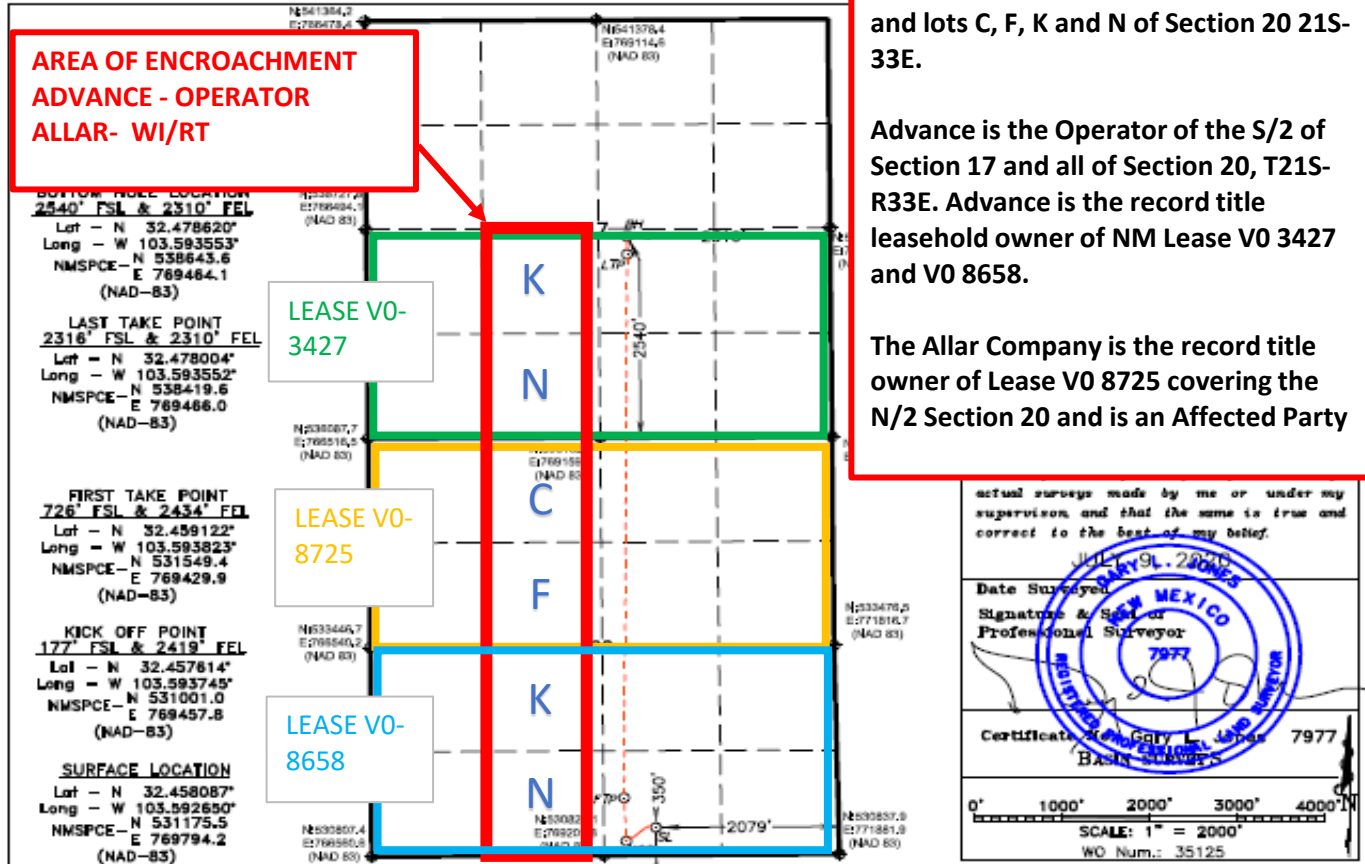

Attached plat displays the as drilled location of the Wool Head 20 State Com 553H. Despite receiving approved drill permits in October 2019, the NM Regulatory Agency recently informed us an NSL approval is required.

The Wool Head 20 State Com 553H surface location is 2079' from east line and 350' from south line, with the first take point 726' from south line and 2434' from east line of Section 20. Last take point is 2310' from east line and 2316' from the south line of Section 17, T21S-R33E.

The New Mexico Regulatory statewide rules provide for wells to be located no closer than 330 feet to the outer boundary of the spacing unit and therefore, the complete interval of the well is unorthodox since it encroaches on the western boundary of the horizontal spacing unit. The first take point along the lateral encroaches upon Units K, N of Section 17 and portions of C, F, K and N of Section 20-T21S-R33E. As record title owner of Lease V0-8725 covering the N/2 Section 20, T21S-R33E, we request The Allar Company confirms this notification and waives of any objection to this well.
