Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on the Goodman 23-22 50H, API Number 30-015-Pending, Property Code Pending. The 50H well is proposed to be completed in the N. Seven Rivers; Glorieta-Yeso pool, Pool Code 97565. The proposed wellbore is to be completed within 330' feet of the S/2 of the N/2 of Sections 23 and 22. The proposed interval is projected as follows:

Surface Hole – 940' FNL 1985' FEL Unit B Sec 23 T19S R25E
First Take Point – 1235' FNL 2629' FWL Unit C Sec 23 T19S R25E
Last Take Point – 1235' FNL 2516' FEL Unit B Sec 22 T19S R25E
Bottom Hole – 1235' FNL 2566' FEL Unit B Sec 22 T19S R25E

The adjoining units which the unorthodox location encroaches are located in T19S R25E, Section 23, Units E and F and Section 22, Units G and H.

Approval of the unorthodox, completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

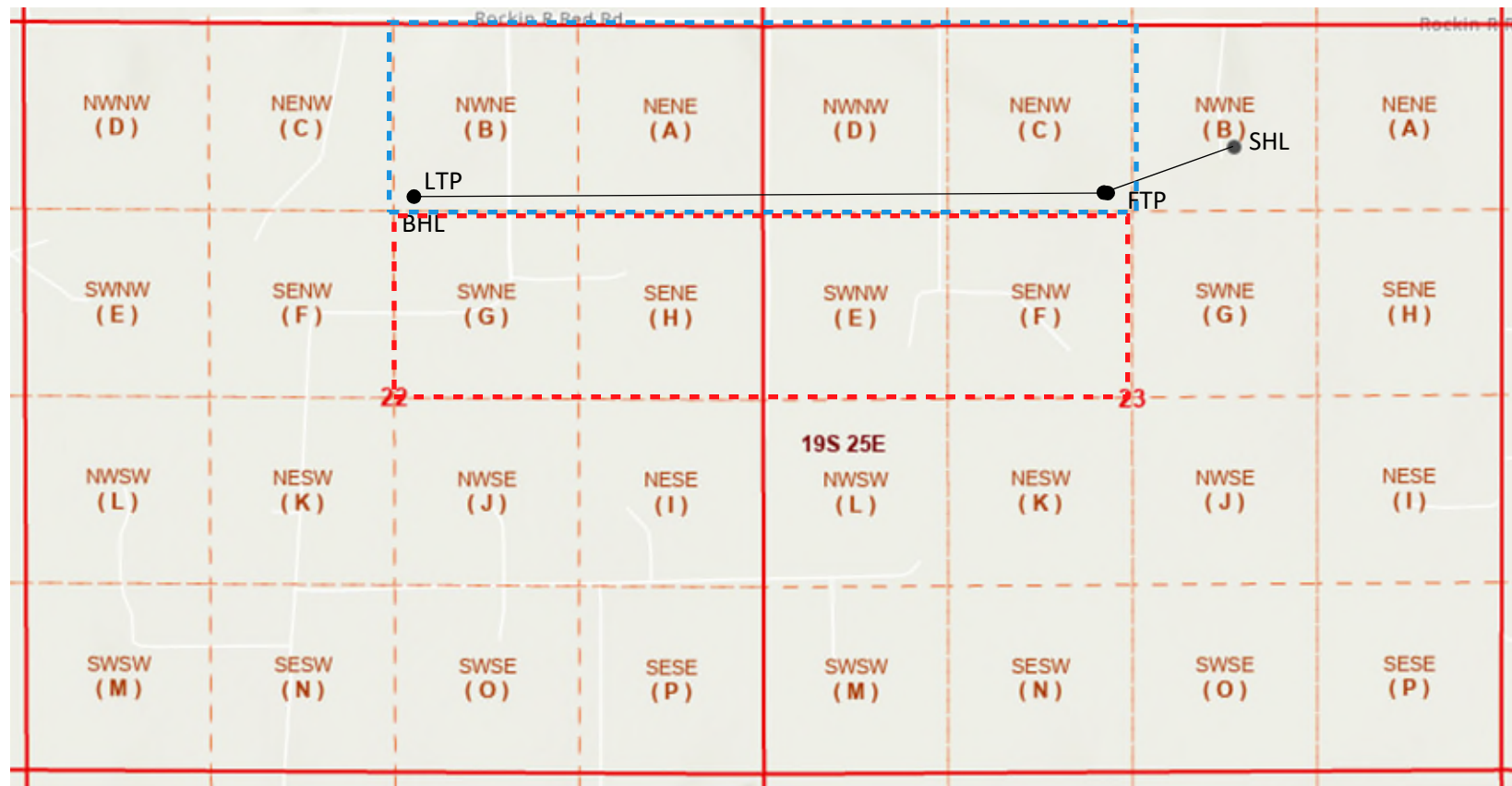
