Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the northern and southern boundary of the spacing unit – thus encroaching on the N/2 of Section 21, T26S, R30E and the lands south of the spacing unit across the New Mexico and Texas border. As explained in the engineering statement included as **Exhibit A**, approval of the unorthodox, completed interval will allow WPX to use its preferred first and last take points for the horizontal well, which will maximize recovery and prevent waste.

Exhibit B is a Form C-102 showing the proposed well encroaches on the spacing unit/tracts to the north in the N/2 of Section 21, T26S, R30E and in the lands south of the spacing unit across the New Mexico and Texas border.


