Devon Energy Production Company, L.P., ("Devon"), OGRID No. 6137, is seeking from the Oil Conservation Division ("Division") administrative approval of an unorthodox well location ("NSL") for the Mr Potato Head 11-14 Fed Com 833H Well (the "833H Well") (API 30-015-Pending) to be completed within the Purple Sage; Wolfcamp Pool (Pool Code 98220) underlying lands in Sections 11 and 14, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): Located in Section 11-T24S-R29E: 200' from the North line and 1976' from the West line of said Section.
- Bottom Hole Location (BHL): Located in Section 14-T24S-R29E: 20' from the South line and 2150' from the West line of said Section.
- First Take Point (FTP): Located in Section 11-T24S-R29E: 100' from the North line and 2150' from the West line of said Section.
- Last Take Point (LTP): Located in Section 14-T24S-R29E: 100' from the South line and 2150' from the West line of said Section.

This well will produce from the Purple Sage; Wolfcamp Pool (Pool Code 98220) The standup unit follows special field rules for the Purple Sage; Wolfcamp formation as described in OCD Order No. R-14262, and the completed interval for the proposed well is closer than 330' from the border of the spacing unit at the end points of the lateral.

The unorthodox location will encroach towards (1) an adjacent unit operated by Devon covering Section 2-T24S-R29E, and Section 35-T24S-R29E; and (2) an adjacent unit operated by OXY USA, Inc. covering the N/2 of Section 23 and the NW/4 of Section 24, in T24S-R29E

Since Devon is the operator in the adjacent unit in Sections 2 and 35, Devon has provided notice to the working interest owners in said adjacent unit pursuant to NMAC 19.15.4.12A(2). And Devon has provided notice to the operator in the adjacent unit in the N/2 of Section 23 and the NW/4 of Section 24. 
