Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, is seeking from the Oil Conservation Division (“Division”) administrative approval of an unorthodox well location (“NSL”) for the Mr Potato Head 11-14 Fed Com 834H Well (the “834H Well”) (API 30-015-Pending) to be completed within the Purple Sage; Wolfcamp Pool (Pool Code 98220) underlying lands in Sections 11 and 14, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): Located in Section 11-T24S-R29E: 200’ from the North line and 2006’ from the West line of said Section.
- Bottom Hole Location (BHL): Located in Section 14-T24S-R29E: 20’ from the South line and 2430’ from the East line of said Section.
- First Take Point (FTP): Located in Section 11-T24S-R29E: 100’ from the North line and 2430’ from the East line of said Section.
- Last Take Point (LTP): Located in Section 14-T24S-R29E: 100’ from the South line and 2430’ from the East line of said Section.

Devon has included as Exhibit B a letter from its reservoir engineer explaining why this application is needed. This well will produce from the Purple Sage; Wolfcamp Pool (Pool Code 98220) The standup unit follows special field rules for the Purple Sage; Wolfcamp formation as described in OCD Order No. R-14262, and the completed interval for the proposed well is closer than 330' from the border of the spacing unit at the end points of the lateral.

The unorthodox location will encroach towards (1) an adjacent unit operated by Devon covering Section 2-T24S-R29E, and Section 35-T24S-R29E; and (2) an adjacent unit operated by OXY USA, Inc. covering the N/2 of Section 23 and the NW/4 of Section 24, in T24S-R29E

Since Devon is the operator in the adjacent unit in Sections 2 and 35, Devon has provided notice to the working interest owners in said adjacent unit pursuant to NMAC 19.15.4.12A(2). And Devon has provided notice to the operator in the adjacent unit in the N/2 of Section 23 and the NW/4 of Section 24. Devon has also provided notice to the Bureau of Land Management (BLM), as an affected person, as is customary in an NSL application when they own royalty interest in federal leases with respect to the lands involved. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing and a copy of the notice letter sent to listed affected persons and parties are attached hereto as Exhibit D and E, respectively.

This NSL application for the Mr Potato Head 11-14 Fed Com 834H Well is part of Devon's initiative to develop all of Sections 11 and 14, Township 24 South, Range 29 East, NMPM under a voluntary operating agreement in which Devon owns 100% of the working interest, therefore no Division compulsory pooling cases or orders are involved in this matter. Sections 11 and 14 will also contain Mr Potato Head 11-14 Fed Com Wells 831H, 833H and 822H, for which Devon has also applied for approval of nonstandard locations in separate NSL applications.

Your consideration in this matter is appreciated.

Devon Energy Production Company, LP ("Devon") respectfully requests administrative approval of a non-standard location for the Mr Potato Head 11-14 Fed Com 834H (the "Well") referenced above. The Well is in the Purple Sage; Wolfcamp Pool (Pool Code 98220) with first and last take points planned at roughly 100' FNL and FSL, respectively. It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last tank points from 330' will allow for increase in potential completed horizontal lateral, thereby increasing the ultimate recovery of reserves and thereby preventing waste of natural resources.

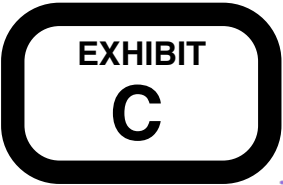
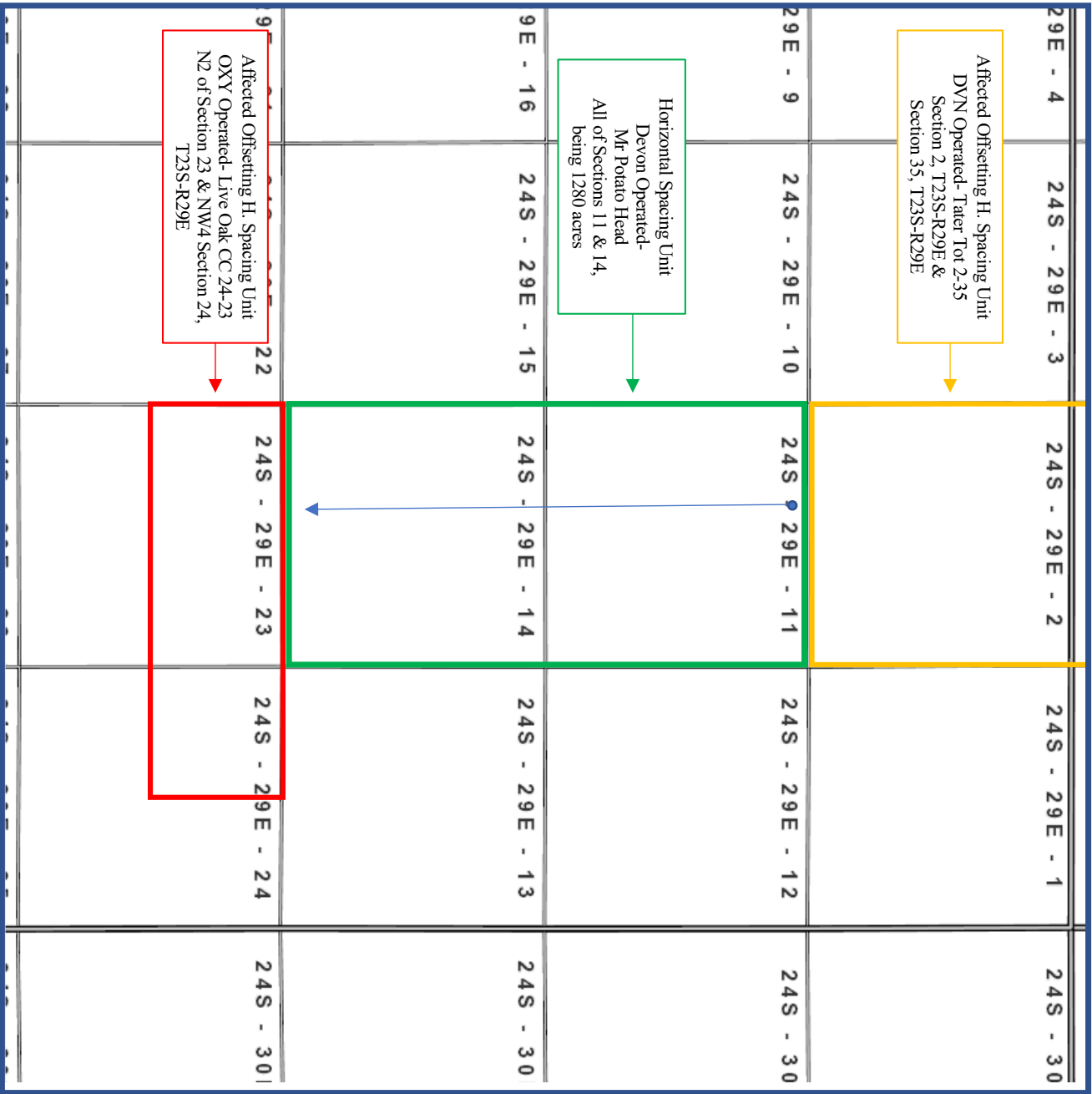
