Devon Energy Production, LP ("Devon") (OGRID No. 6137) seeks to amend Administrative Order NSL-8059, attached as **Exhibit A**, for approval of an unorthodox as-drilled location for its **Shetland 11-2 Fed State Com #732H well** (API No. 30-015-47159) to be completed within the Purple Sage Wolfcamp Pool (98220) underlying Sections 2 and 11, Township 26 South, Range 31 East, N.M.P.M., Eddy County, New Mexico.

This well has been drilled as follows, with locations different than approved under Administrative Order NSL-8059:

- <u>surface location</u>: 350 feet from the south line and 2140 feet from the west line (Unit N) of Section 11 instead of 350 feet from south line and 2140 from the west line (Unit N) of Section 11;
- <u>bottom hole location</u>: 35 feet from the north line and 2322 feet from the east line (Unit B) of Section 2 instead of 20 feet from the north line and 2310 from the west line (Unit C) of Section 2;
- first take point: 666 feet from the south line and 2538 feet from the west line (Unit N) of Section 11 instead of 100 feet from the south line and 2310 from the west line (Unit N) of Section 11; and

• <u>last take point</u>: 160 feet from the north line and 2330 feet from the west line (Unit B) of Section 2 – instead of 100 feet from the north line and 2310 from the west line (Unit C) of Section 2.

Pursuant to Division Order R-14262, this acreage is governed by the Special Rules for the Purple Sage-Wolfcamp Gas Pool which provide for wells in the Wolfcamp formation in Eddy County to be located no closer than 330 feet to the outer boundary of the spacing unit. The completed interval for the **Shetland 11-2 Fed State Com #732H well** will be unorthodox because the last take point is closer than 330 feet to the northern boundary of the spacing unit. As stated in Devon's original application, approval of the unorthodox, completed interval will allow Devon to increase the lateral length by several hundred feet, thereby increasing ultimate recovery of reserves and preventing waste of natural resources.

Exhibit B is a Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Shetland 11-2 Fed State Com #732H well** encroaches on the drilling and spacing unit to the north in Section 35, Township 25 South, Range 31 East.

Ownership is diverse between the subject spacing unit and the affected spacing units to the north. **Exhibit C** reflects that a copy of this application with all attachments has been sent by certified mail to each affected person advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application.

Exhibit D is a land plat for Sections 2 and 11 that shows the proposed **Shetland 11-2 Fed State Com #732H well** in relation to the adjoining spacing unit to the north in Section 35 where Devon provided notice.


