Dear Mr. Lowe,

Matador Production Company respectfully requests administrative approval of a non-standard location for our Rey B 13-17S-37E #1 (API 30-025-pending), to be completed in the Humble City; Strawn, South (Pool Code 33500).

Matador's Rey B 13-17S-37E #1 (API 30-025-pending) is a directional well to be completed only at the bottom hole location. The special pool rules for the Humble City; Strawn, South (Pool Code 33500) were set forth in Division Order R-6913. Pursuant to those special pool rules:

- a. Each well shall be located on a standard unit containing 80 acres, more or less, consisting of the N/2, S/2, E/2 or W/2 of a governmental quarter section; and
- b. Each well shall be located within 150 feet of the center of a governmental quarter-quarter section or lot.

As set forth below, Matador's application requests a non-standard location because the proposed bottom hole is located outside 150 feet of the center of the subject governmental quarter-quarter section. Matador will be filing its application for a drilling permit for this well separately in the near future.

1. Well name: Rey B 13-17S-37E #1 (API 30—025—pending)
2. Pool: Humble City; Strawn, South (Pool Code 33500)
3. Spacing Unit: W/2 NE/4 of Section 13, Township 17 South, Range 37 East, NMPM, Lea County, New Mexico.
This is a standard spacing unit in this pool pursuant to Division Order R-6913. A copy of a draft form C102 for the well is enclosed. The well will be the first well drilled in this spacing unit; therefore, it is the defining well for the spacing unit.
4. Acreage in Spacing Unit: 80 acres.
5. Directional Well Location:
 - a. Directional Well Surface Location: 340' FNL, 2,373 FEL of Section 13, T17S, R37E, Lea County, New Mexico.
 - b. Directional Well Bottom Hole Location: 701' FNL, 2,362' FEL of Section 13, T17S, R37E, Lea County, New Mexico.
 - c. Directional Well's Completed Interval: The well's entire completed interval will be located at the bottom hole location; specifically, 701' FNL, 2,362' FEL of Section 13, T17S, R37E, Lea County, New Mexico.
6. Matador requests this non-standard location because it will allow for the most efficient development of this acreage, thereby preventing waste. Specifically, as set forth in the attached letter from Matador's Vice President of Geology, 3D seismic has revealed discrete reservoirs within the Strawn formation in this area, including the discrete reservoir Matador is targeting with this proposed well. Matador's proposed bottom hole location—701' FNL, 2,362' FEL of Section 13, T17S, R37E, Lea County, New Mexico—is located where Matador believes it can most efficiently drain the discrete reservoir identified on this acreage. Matador does not believe it can efficiently drain this reservoir from a standard location within 150 feet of the center of a quarter-quarter section, and believes that attempting to do so would leave significant production volumes in place and result in waste. Accordingly, the granting of Matador's application would prevent this waste and lead to the most efficient development of this acreage.
7. The well is in an oil pool and we anticipate the well will produce both oil and gas.
8. Pursuant to NMAC 19.15.4.12(A)(2), the affected persons in this circumstance are those located in the adjoining quarter section because the spacing unit that is the subject of this application is greater than 40 acres under the special pool rules. Accordingly, the area of encroachment is the NW/4 of Section 13, T17S, R37E, Lea County, New Mexico.

Dear Mr. Lowe,

I am writing in support of Matador Production Company's application for approval of a non-standard location for our Rey B 13-17S-37E #1 (API 30-025-pending), to be completed in the Humble City; Strawn, South (Pool Code 33500).

Matador has access to 3D seismic data covering the Strawn formation on this acreage. Based on our interpretation of that 3D seismic data, we have found that there are discrete reservoirs within the Strawn formation in this area, including the discrete reservoir Matador is targeting with this proposed well. Matador's proposed bottom hole location—701' FNL, 2,362' FEL of Section 13, T17S, R37E, Lea County, New Mexico—is located where we believe we can most efficiently drain the discrete reservoir we have identified on this acreage. We do not believe we can efficiently drain this reservoir from a standard location within 150 feet of the center of a quarter-quarter section, and we believe that attempting to do so would leave significant production volumes in place and result in waste. The granting of Matador's application would prevent this waste and lead to the most efficient development of this acreage.

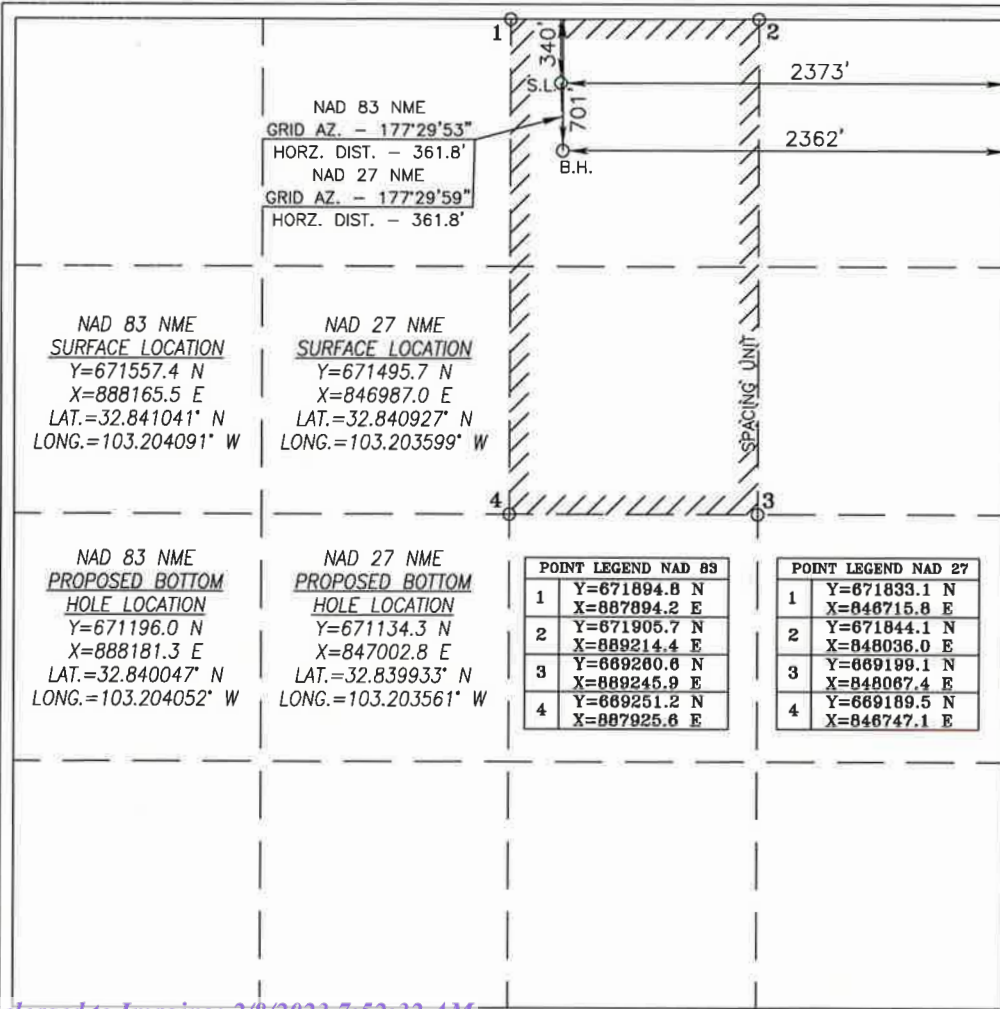

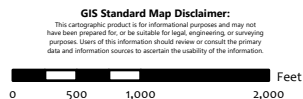
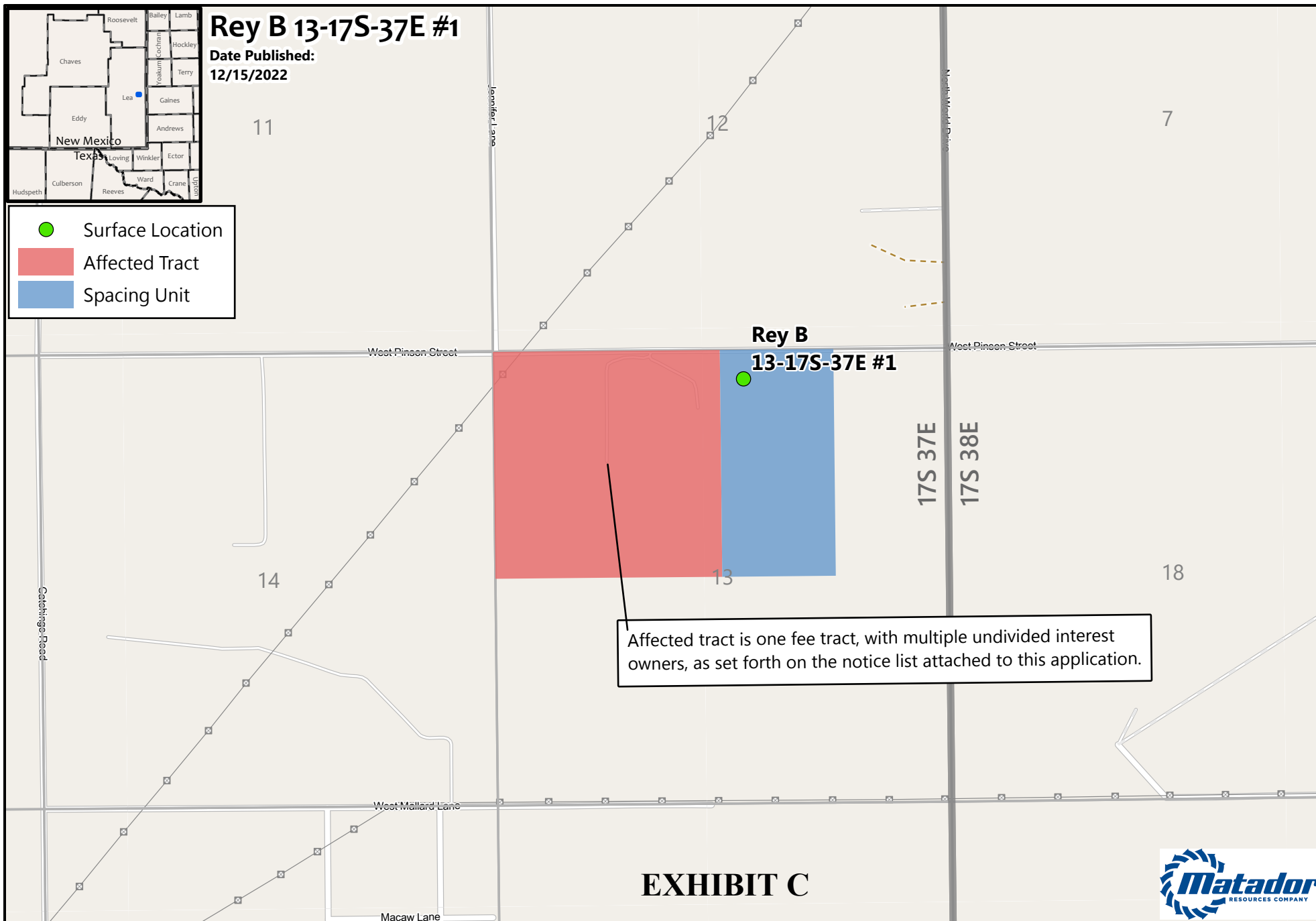
