Devon Energy Production Company, L.P. (OGRID No. 6137), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the Bobcat Draw; Upper Wolfcamp (oil), pool [Pool Code 98094], seeks administrative approval of an unorthodox well location for its **Jayhawk 7-6 Fed Fee Com #20H** well (API No. 30-025-48640), in a 320-acre, more or less, spacing unit underlying the E/2 E/2 of irregular Sections 6 and 7, T26S-R34E, Lea County, New Mexico.

The **Jayhawk 7-6 Fed Fee Com #20H** well is an infill well. The **Jayhawk 7-6 Fed Fee Com #7H** well is the defining well, creating the spacing unit.

The proposed location for the **Jayhawk 7-6 Fed Fee Com #20H** well is as follows:

- Surface location: 875' FSL and 2,125' FEL (Unit O) of irregular Section 7
- First take point: 100' FSL and 1,060' FEL (Unit P) of irregular Section 7
- Last take point: 100' FNL and 1,060' FEL (Unit A) of irregular Section 6
- Bottom location: 20' FSL and 1,060' FEL (Unit A) of irregular Section 6

Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the western boundary of the spacing unit; thus, encroaching on the W/2 E/2 of irregular Sections 6 and 7, T26S-R34E.

Devon Energy Production Company, L.P. respectfully requests administrative approval of a non-standard location for the **Jayhawk 7-6 Fed Fee Com #20H** well to allow the completed interval to be less than 330 feet from the western boundary of the existing 320.00-acre horizontal spacing unit. This well is located in the Bobcat Draw Pool, code 98094. Due to the current spacing of the producing wells in these sections, Devon Energy Production Company, L.P. has planned the Jayhawk Fed Fee Com wells with at least 660 feet of spacing between each like kind well. This spacing pattern causes the **Jayhawk 7-6 Fed Fee Com #20H** well to be drilled less than 330 feet from the western boundary of the spacing unit. Devon Energy Production Company, L.P. requests approval of this non-standard location to avoid causing wasted resources and reducing the production of the wells listed above.

Exhibit A is a Form C-102 showing the Jayhawk 7-6 Fed Fee Com #20H well encroaches on the spacing unit/tracts to the west in the W/2 E/2 of irregular Sections 6 and 7, T26S-R34E. Additionally, included is a Form C-102 for the Jayhawk 7-6 Fed Fee Com #7H well, showing it is the defining well for the spacing unit.

Exhibit B is a plat for irregular Sections 6 and 7, T26S-R34E, that shows the proposed Jayhawk 7-6 Fed Fee Com #20H well in relation to the adjoining spacing unit/tracts to the west. Exhibit B also includes an ownership list for the affected spacing unit to the west, showing that it is operated by Devon Energy Production Company, L.P., and lists the other working interest owners in the offsetting unit. In addition, the exhibit identifies that these include a Federal lease. Accordingly, the "affected persons"¹ are the applicant, Devon Energy Production Company, L.P., the other working interest owners listed in Exhibit B, and the Bureau of Land Management.

Exhibit C is a spreadsheet listing all affected persons and includes tracking information demonstrating that each of the affected persons was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 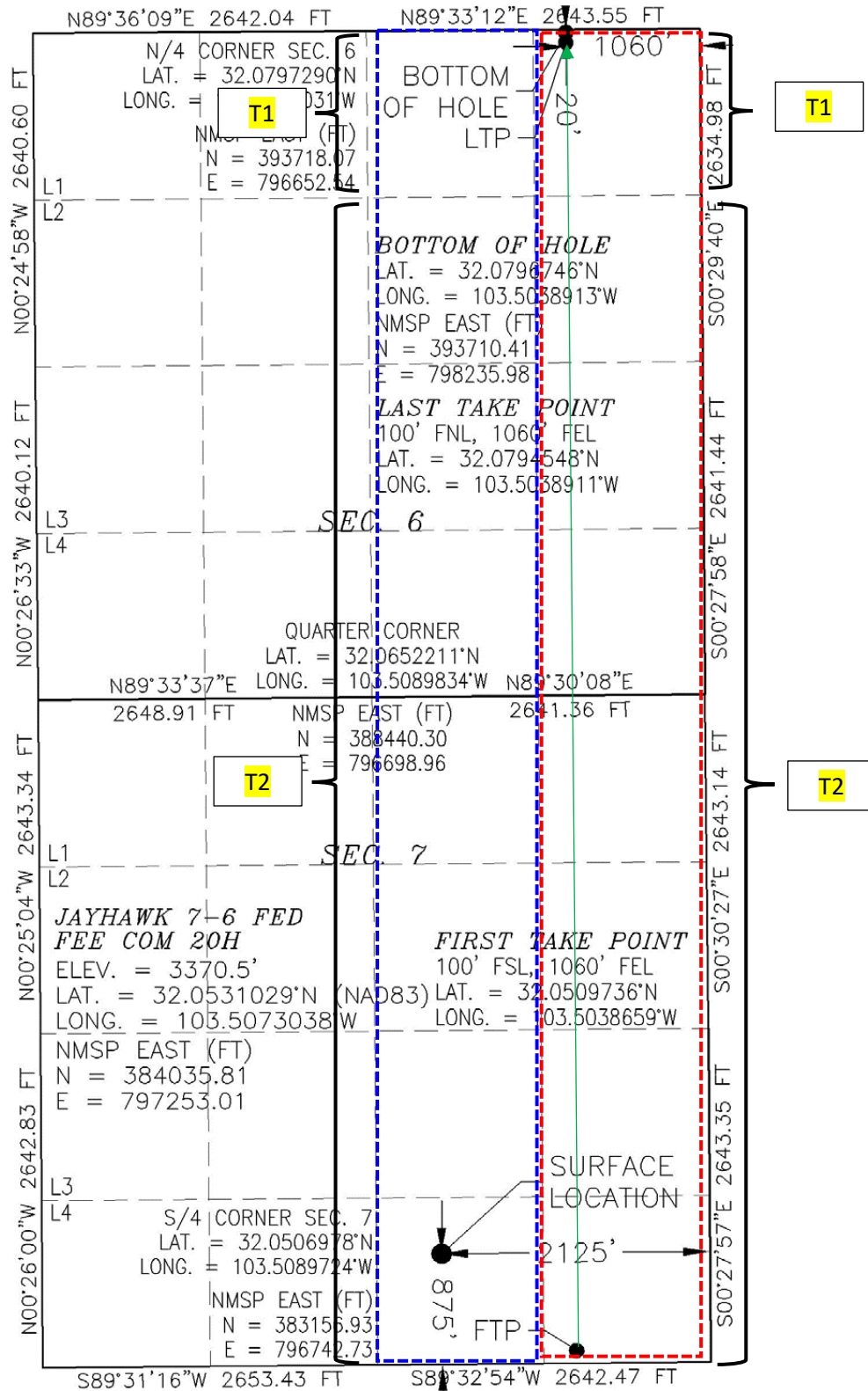
