Dear Director Fuge,

EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its Caravan 28 State Com No. 203H well (APD not yet submitted), which will be dedicated to a 320-acre spacing unit comprised of the W/2W/2 of Sections 28 and 33, Township 24 South, Range 33 East, NMPM, Lea County, New Mexico. The spacing unit does not include proximity tracts. The well is expected to be placed into the Triste Draw; Bone Spring, East pool (96682).

The well has not yet been drilled. The proposed location is as follows:

- The <u>surface location</u> is located 543 feet from the North line, 1504 feet from the West line (Unit C) of Section 28,
- The <u>bottom hole location</u> is located 100 feet from the South line, 1220 feet from the West line (Unit M) of Section 33,
- The <u>first take point</u> is located 100 feet from the North line, 1220 feet from the West line (Unit D) of Section 28,
- The <u>last take point</u> is located 100 feet from the South line, 1220 feet from the West line (Unit M) of Section 33.

The acreage is governed by the Division's statewide rules. The proposed completed interval is unorthodox because it will be closer than 330 feet to the eastern boundary. It encroaches on the spacing units in the E/2W/2 of Sections 28 and 33. Approval of the unorthodox location will allow EOG to use its preferred well spacing plan for horizontal wells, which will prevent waste.

Exhibit A is the draft C-102 showing the location of the well, including the proposed unorthodox completed interval. The completed interval encroaches on the spacing unit/tracts to the east.

Exhibit B is a plat that shows the Caravan 28 State Com No. 203H well in relation to the adjoining spacing units/tracts to the east.

EOG is the operator of the spacing units to the east, however, ownership is diverse between the subject spacing unit and the affected spacing unit/tracts to the east. **Exhibit C** is a certification from the landman indicating that he has reviewed the tracts affected by this request. Exhibit C includes a list of the affected parties and proof that a copy of this application, including exhibits, was mailed to each affected party. This notice advises affected parties that any objection must be filed in writing with the Division within 20 days from the date the Division receives the application.


