## **ADMINISTRATIVE NON-STANDARD HORIZONTAL SPACING UNIT**

### Mewbourne Oil Company [OGRID 14744]

You have requested an approval for a non-standard horizontal spacing unit as follows:

You have requested an exception pursuant to Rule 19.15.16.15(B)(2) NMAC, to approve a nonstandard horizontal spacing unit comprising 640 acres, consisting of the entire area described above as the horizontal spacing unit. The proposed horizontal spacing unit does not consist of a quarter - quarter section, as required by Rule 19.15.16.15(B)(1) NMAC.

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units which are being included.

You have requested this non-standard horizontal spacing unit to develop acreage as a single unit in order to consolidate roads, tanks, pipelines and the use of a single surface facility. Thus, reducing waste while protecting the correlative rights within the Bone Spring formation underlying Section 11 and Section 10.

Pursuant to the authority conferred by Division Rule 19.15.16.15(B)(5) NMAC, the abovedescribed **non-standard horizontal spacing unit is hereby approved**. Further, the Applicant may add additional wells to the horizontal spacing unit. The additional well(s) shall be designated to the same horizontal spacing unit and pool/formation.
