Whitney McKee:

The Oil Conservation Division ("OCD") has reviewed the February 14, 2022, request to extend the deadline in the referenced order to commence injection into referenced well. The request, which was received prior to the deadline, states the reasons for granting an extension, that no additional wells penetrating the approved injection interval have been drilled within the Area of Review since the referenced order was granted, and that additional affected parties in the AOR, if any, were notified of your extension request and did not protest the extension. Accordingly, OCD reviews your request administratively.

The OCD finds that for reasons you have stated, the granting of this request to extend the deadline is in the interest of conservation, will prevent waste, and will protect the environment. Therefore, the deadline to commence injection for the existing order is hereby extended until **March 22, 2024**. An additional request to extend the deadline to inject will be contingent upon the well being spudded and the OCD being provided plans to complete the well within the following year. Additionally, a subsequent extension request will not be granted for this order to an operator other than Solaris Water Midstream, LLC.

All requirements of the above referenced administrative order and agreements in the application remain in full force and effect. Any further extension of the deadline to commence injection shall be considered but must be submitted in writing prior to the new extended deadline.
