You have requested to drill this horizontal well at an unorthodox oil well location described above in the referenced pool or formation. 19.15.16.15(B)(1)(a) NMAC governs this proposed well and provides that the operator shall dedicate to each horizontal oil well a standard horizontal spacing unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter - quarter section or equivalent.

This well's completed interval is as close as 280 feet to a Quarter section that is not included in the unit towards the eastern edge of the horizontal spacing unit. Encroachment will impact the following tract(s).

Division understands you are seeking this unorthodox location to allow for efficient spacing of horizontal wells within the Wolfcamp formation. Thereby preventing waste within the formation underlying the E/2 E/2 of Section 27, the E/2 E/2 of Section 34, the W/2 W/2 of Section 26, and the W/2 W/2 of Section 35.


Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.
