OXY USA Inc. respectfully requests administrative approval of a non-standard location on the Corral Bluff 11-14 Federal Com 34H well, API Number 30-015-47770, Property Code 329731. The #34H well is proposed to be completed in the Purple Sage Wolfcamp pool, Pool Code 98220 which has special pool rules specifying the completed interval must be located 330 feet from the exterior boundary of the applicable spacing unit. The proposed completed interval is projected as follows:

Surface – 251' FSL 2241' FWL Unit N Sec 2 T25S R29E
First Take Point – 100' FNL 2380' FWL Unit C Sec 11 T25S R29E
Last Take Point – 100' FSL 2380' FWL Unit N, Sec 14 T25S R29E
Bottom Hole – 20' FSL 2380' FWL Unit N, Sec 14 T25S R29E

OXY has planned a Horizontal Spacing Unit of 640-acres including the West ½ of section 11 and section 14, T25S R29E, not utilizing the 160-acre proximity building blocks. OXY will file a NSP application separately for this PSW HSU.

- The adjoining units which the unorthodox location encroaches are located to the North in T25S R29E, Section 2 – Units L, K, M, N, which is operated by Contango Oil & Gas Company.
- To the South the adjoining units which the unorthodox location encroaches are in T25S R29E, Section 23 – Units D, C, E, F, which is operated by COG Production, LLC & XTO Holdings, LLC.
- The adjoining units which the unorthodox location encroaches are located to the East in T25S R29E, Sections 11, 12, 13 & 14 (Existing 1280-acre HSU) – Sections 11 & 14 Units A, B, G, H, I, J, O, P, and Sections 12 & East Units C, D, E, F, K, L, M, N, which is operated by OXY USA Inc. with XTO Holdings, LLC as a Working Interest Owner.

Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

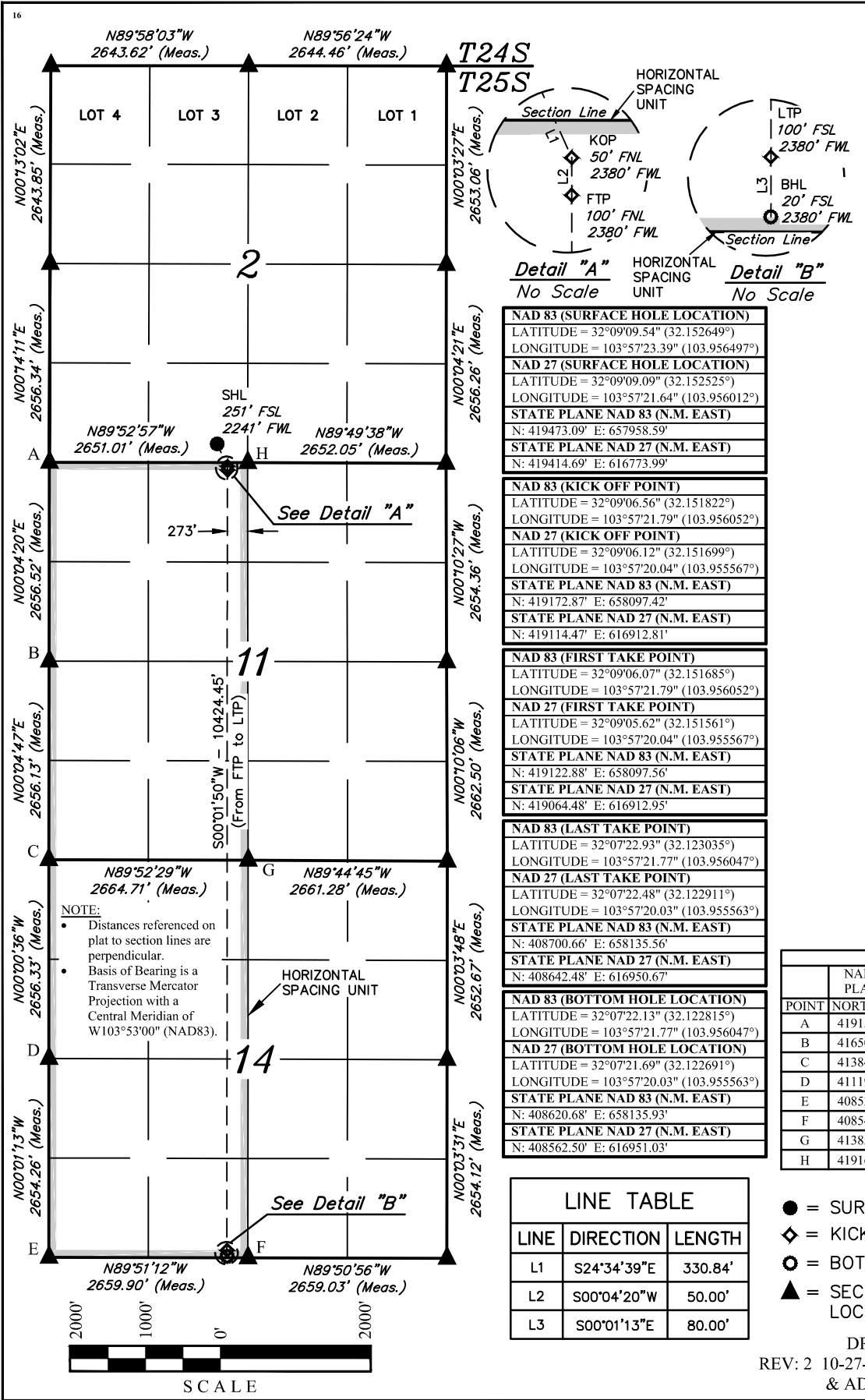

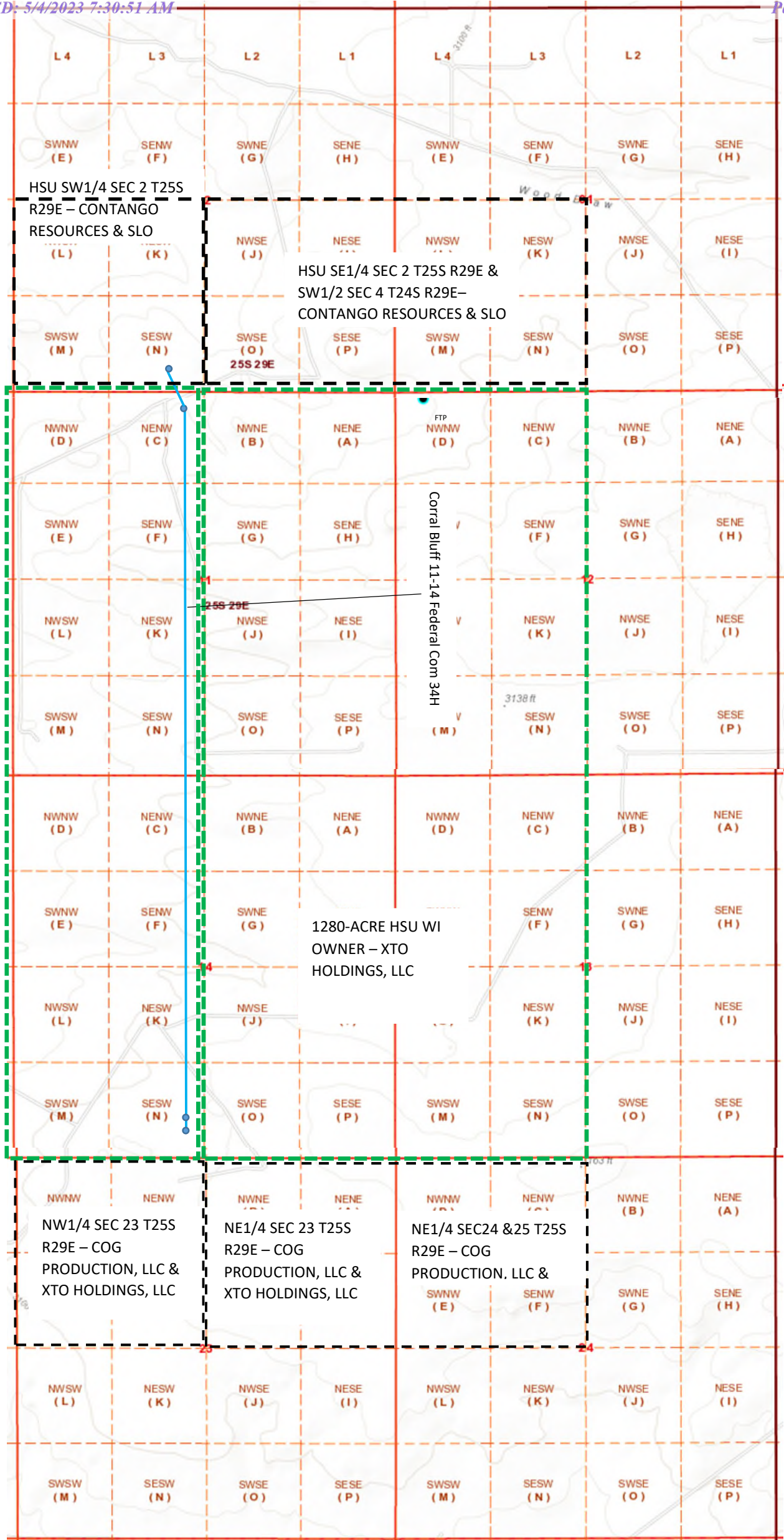

Dear Mr. Lowe:

Oxy USA Inc. respectfully seeks approval for a non-standard location, decreasing the first and last take point for the below list of Corral Bluff 11-14 Federal Com wells in the Wolfcamp formation of the Purple Sage Pool from 330 feet to 100 feet. It is Oxy's responsibility as a prudent operator to maximize lateral length and minimize reserves left in the ground. Decreasing the first and last take point will increase this well's effective lateral length by 460 feet and increase the estimated ultimate recovery of the well by approximately 5%. Any increase in first or last take point would result in untapped reserves left in the reservoir, and waste of a resource that would otherwise go undeveloped.

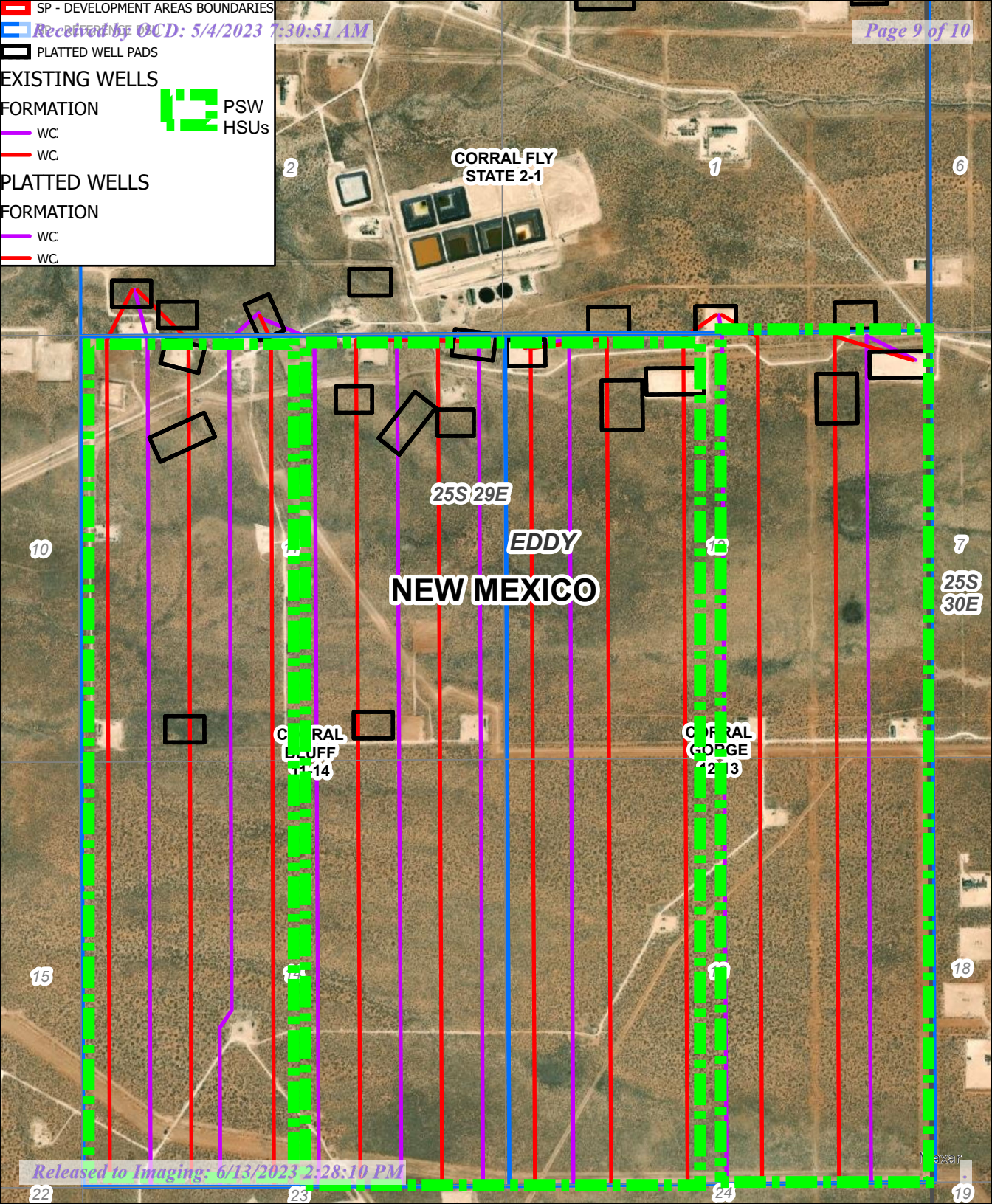
