the spacing unit—thus, encroaching on Permian's Sheba spacing unit/tracts to the east, comprising the E/2 of Section 22 and the E/2 NE/4 of Section 27, T24S-R34E. As explained in the engineering statement included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Permian to use its preferred well spacing plan for horizontal wells in this area, which will maximize recovery and prevent waste.

Exhibit B is a Form C-102 showing the **Solomon Federal Com #105H** well encroaches on the tracts to the east in the E/2 E/2 of Section 22 and the E/2 NE/4 of Section 27, T24S-R34E.




