Chevron U.S.A. Inc. ("Chevron") (OGRID No. 4323), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the Antelope Ridge; Bone Spring, West [2209], seeks administrative approval of an unorthodox well location for its **ZN 27 22 Fed State Com #401H** well (API No. 30-025-PENDING), in a 320-acre, more or less, horizontal well spacing unit comprised of the W/2 E/2 of Sections 22 and 27, Township 23 South, Range 34 East, NMPM, Lea County, New Mexico.

The proposed location for the ZN 27 22 Fed State Com #401H is as follows:

- Surface hole location: 650' FNL and 1,367' FEL (Unit B) of Section 34




