Chevron U.S.A. Inc. ("Chevron") (OGRID No. 4323), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the Antelope Ridge; Bone Spring, West [2209], seeks administrative approval of an unorthodox well location for its **ZN 27 22 Fed State Com #402H** well (API No. 30-025-PENDING), in a 320-acre, more or less, horizontal well spacing unit comprised of the E/2 E/2 of Sections 22 and 27, Township 23 South, Range 34 East, NMPM, Lea County, New Mexico.

The proposed location for the ZN 27 22 Fed State Com #402H is as follows:

- Surface hole location: 650' FNL and 1,327' FEL (Unit B) of Section 34
- First take point: 25' FSL and 660' FEL (Unit P) of Section 27
- Last take point: 100' FNL and 660' FEL (Unit A) of Section 22
- Bottom hole location: 25' FNL and 660' FEL (Unit A) of Section 22

Since this acreage is governed by the Division's statewide oil rules, the completed first take point for this well will be unorthodox because it is closer than the standard offset to the southern boundary of the spacing unit—thus, encroaching on the E/2 of Section 34.




