This directional well will be completed within an unorthodox well location described above in the referenced pool or formation. This location is governed by special pool rule, R – 3816, which provides for 80-acre units, with wells to be located at least 150 feet from the center of the quarter - quarter section.

This well's completed interval is as close as 240 feet to the western boundary and 474 feet to the southern boundary. Encroachment will impact the following tracts.

Section 16, encroachment to the SE/4 SW/4
Section 21, encroachment to the NW/4 NE/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.
