This directional well will be completed within an unorthodox well location described above in the referenced pool or formation. This location is governed by special pool rule, R – 3816, which provides for 80-acre units, with wells to be located at least 150 feet from the center of the quarter - quarter section.

This well's completed interval is as close as 84 feet to the southern boundary. Encroachment will impact the following tracts.
