Chevron U.S.A. Inc. ("Chevron") (OGRID No. 4323), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the WC-025 G-08 S243217P; UPR WOLFCAMP (98248), seeks administrative approval of an unorthodox well location for its **MR 35 26 Federal Com #601H** well (API No. 30-025-PENDING), in a 640-acre, more or less, horizontal well spacing unit comprised of the E/2 of 26 and 35, Township 23 South, Range 32 East, NMPM, Lea County, New Mexico.

The MR 35 26 Federal Com #601H oil well is an infill well. The MR 35 26 Federal Com #602H oil well is the defining well, creating the enlarged spacing unit.

The proposed location for the MR 35 26 Federal Com #601H is as follows:

- Surface hole location: 490' FNL and 1,523' FEL (Unit B) of Section 2, T24S-R32E
- First take point: 25' FSL and 2,188' FEL (Unit O) of Section 35, T23S-R32E
- Last take point: 100' FNL and 2,188' FEL (Unit B) of Section 26, T23S-R32E
- Bottom hole location: 25' FNL and 2,188' FEL (Unit B) of Section 26, T23S-R32E

Wyoming Since this acreage is governed by the Division's statewide oil rules, the completed first take point for this well will be unorthodox because it is closer than the standard offset to the southern boundary of the spacing unit—thus, encroaching on the E/2 of Section 2, T24S-R32E.

Chevron U.S.A. Inc. respectfully requests administrative approval of a non-standard location for the MR 35 26 Federal Com #601H and provides the following reason for the request: Approval of the unorthodox, completed interval is necessary to allow Chevron to use its preferred well spacing plan for horizontal wells in this area, which will maximize recovery and prevent waste.

Exhibit A is a Form C-102 showing the proposed MR 35 26 Federal Com #601H well encroaches on the spacing unit/tracts to the south in the E/2 of Section 2, T24S-R32E. Also, included is the Form C-102 for the MR 35 26 Federal Com #602H, the defining well for the spacing unit.

Exhibit B is a plat for the subject area, that shows the proposed MR 35 26 Federal Com #601H well in relation to the adjoining spacing unit/tracts to the south. The affected spacing unit is owned/operated by Chevron; there are no other working interest owners. In addition, the exhibit identifies that this includes a State Land Office ("SLO") lease. Accordingly, the "affected persons" ¹ are Chevron and the SLO.





