This well is governed by special rules, R - 3073, for the Red Hills; Wolfcamp (Gas) Pool and provides for 640-acre proration units, with set back requirements of at least 660 feet from the unit outer boundary and no closer than 10 feet to any interior quarter – quarter section line.
