Good afternoon, Ms. Cowden. In response to your questions on specific UIC permits and applications:

#### Cedar Canyon SWD No. 1; Administrative Order SWD-1872

This application was submitted twice. The original assignment of pending UIC permit number was SWD-1840 with a surface location of UL B-Sec 1-T24S-R29E. This location was protested by XTO Energy, Inc. on October 24, 2018. This application was withdrawn by the Applicant on April 17, 2020. A second C-108 application assigned the pending UIC permit number SWD-1872 was submitted on December 17, 2018, with a new surface location (1602' FNL & 2368' FEL; UL G-Sec 1-T24S-R29E). Currently in pending status with no protests. Applicant assigned a "Priority 3" or lowest priority for processing when OCD requested ranking of outstanding OWL applications (applicant e-mail dated April 20, 2020). As a result, neither admin complete review of technical review has been performed on this application.

## Czervik SWD No. 1; Administrative Order SWD-1841

The administrative order was approved on September 10, 2020. The UIC permit expired on September 10, 2021, without commencing injection within the one-year period and without submitting a written request for extension within the one-year period.

### Goodbye Toby SWD No. 1; Administrative Order SWD-1688

The administrative order was approved on August 14, 2017. The UIC permit contained a two-year period to commence injection with a compliance date of August 14, 2019. Applicant provided the first extension request on July 24, 2019, but OCD did not issued an extension letter. Applicant provided a second extension request on August 3, 2020. OCD honored the first request as approved and continued the permit's authority with the second extension to commence injection by August 14, 2021. The UIC permit expired on August 14, 2021, without commencing injection within the second extension one-year period and without submitting a written request for an additional extension.

### The Office SWD No. 1; Administrative Order SWD-2032

The administrative order was approved on November 9, 2020. The UIC permit expired on November 9, 2021, without commencing injection within the one-year period and without submitting a written request for extension within the one-year period.

Of the four UIC matters, three were approved UIC permits that were allowed to lapse. The first item, the Cedar Canyon, has opportunity for continued administrative review but may require some additional notice.

*How can an operator take a non-commercial saltwater disposal well and make it a commercial SWD?* This item is still being reviewed. Though not contained (defined) in NMAC, the classification of

commercial rose from the steady increase of midstream operators as the primary applicant for disposal wells replacing the historical applicants of oil and gas E&P companies as owner/operators. The category was used to track UIC permits to address information requests from the legislature and the public on these type of operations. But there are conditions in UIC permits which may limit capacity and source of disposal. Usually referred to "lease only" or "operator only" sources, some permits which are hearing orders may have restriction as conditions while some administratively approved UIC permits may include source or volume restrictions as a condition for withdrawal of a protest. Additionally, OCD reviews the original application of the UIC permit for intended purpose for the disposal. My recommendation is to submit a request for a specific well along with the proposed changes in operation.
