C-102s for the Wells are attached as Exhibit A. This is a horizontal well that will be drilled as follows: HSU: E/2 SEC 2, SE/4 SEC 35, E/2 NE/4 & SW/4 NE/4 -OCD-

- Surface Location (SL): 240' from the South line and 785' from the East line of Section 2, Township 24 South, Range 29 East;

The completed interval for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the (1) E/2 S/2 of Section 26, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico; and (2) the E/2 N/2 of Section 11, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico.




