Devon Energy Production Company, L.P., ("Devon"), OGRID No. 6137, is seeking administrative approval of unorthodox well location ("NSL") for the Tater Tot 2-35 Fed Com 624H Well (API 30-015-49050) to be completed within the Purple Sage; Wolfcamp Pool (Pool Code 98220) underlying the ~~E/2 of Section 2~~, Township 24 South, Range 29 East NMPM, Eddy County, New Mexico, and the ~~E/2 of Section 35~~, Township 23 South, Range 29 East NMPM, Eddy County, New Mexico. C-102s for the Wells are attached as Exhibit A. This is a horizontal well that will be drilled as follows: **HSU: E/2 SEC 2, SE/4 SEC 35, E/2 NE/4 & SW/4 NE/4** -ocd-

- Surface Location (SL): 240' from the South line and 785' from the East line of Section 2, Township 24 South, Range 29 East;
- Bottom Hole Location (BHL): 20' from the North line and 600' from the East line of Section 35, Township 23 South, Range 29 East;
- First Take Point (FTP): 100' from the South line and 600' from the East line of Section 2, Township 24 South, Range 29 East;
- Last Take Point (LTP): 100' from the North line and 600' from the East line of Section 35, Township 23 South, Range 29 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330' foot setback requirements. The completed interval for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the (1) E/2 S/2 of Section 26, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico; and (2) the E/2 N/2 of Section 11, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico.

Devon attests that, on or before submission of this application, it provided notice to the affected persons (1) in the adjoining E/2 S/2 of Section 26, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico; however, the interest which the well encroaches toward the E/2 N/2 of Section 11, Township 24 South, Range 29 East, is owned 100% by Devon, so no notice is required; said notice as described satisfies all provisions of NMAC 19.15.4.12A(2); copies of the application and required plat maps were furnished. Devon also provided notice to the Bureau of Land Management to the extent that they own interest with respect to offsetting areas. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. There is no compulsory pooling case associated with this well.

Devon Energy Production Company, LP ("Devon") respectfully requests administrative approval of a non-standard location for the Tater Tot 2-35 Fed Com 624H (the "Well") referenced above. The Well is in the Purple Sage; Wolfcamp Pool (Pool Code 98220) with first and last take points planned at roughly 100' FSL and FNL, respectively. It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last take points from 330' will allow for increase in potential completed horizontal lateral, thereby increasing the ultimate recovery of reserves and thereby preventing waste of natural resources.

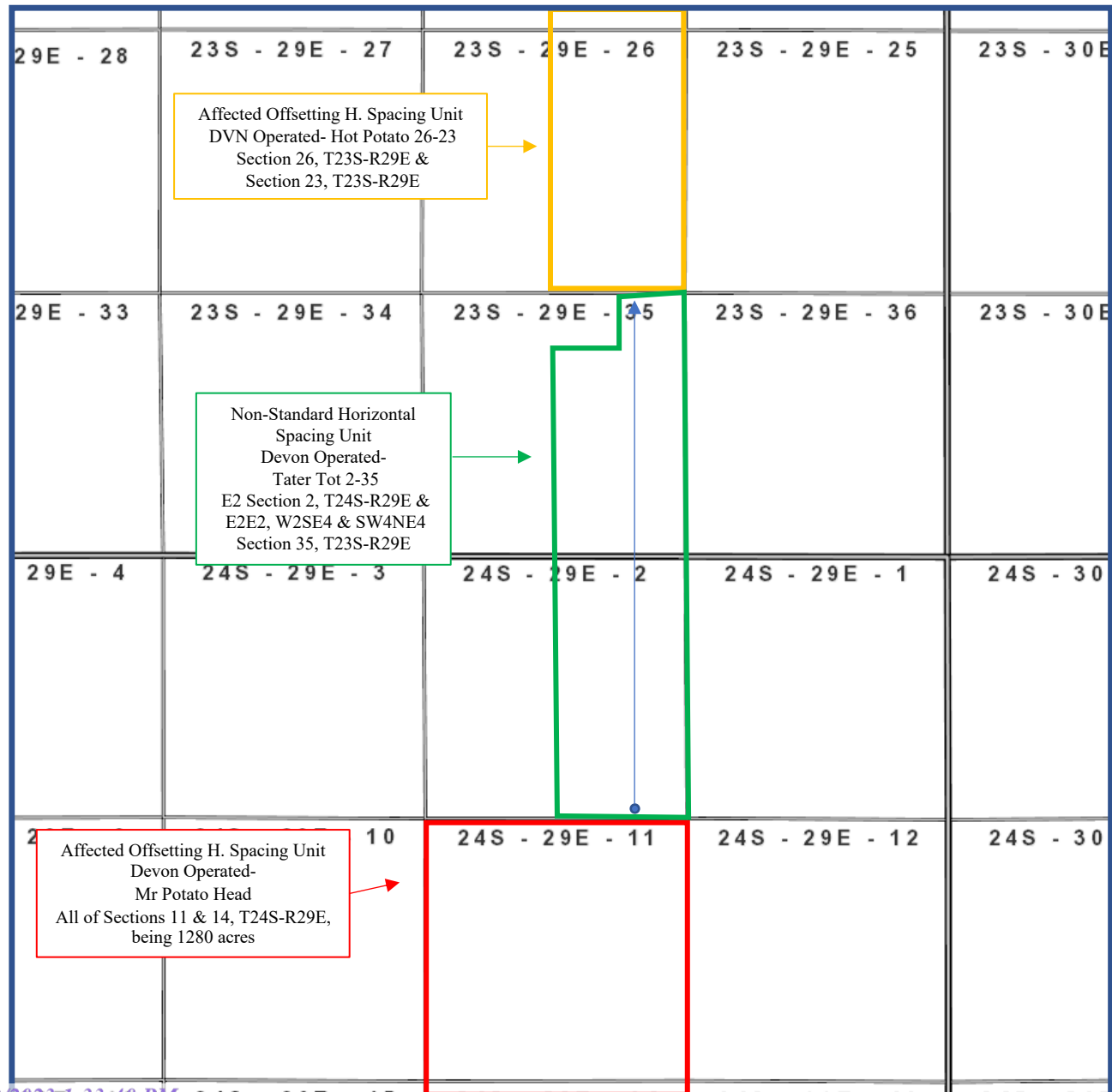
