You have requested approval of a non-standard horizontal spacing unit to be included in your proposed horizontal spacing unit, as follows:

You have requested this non-standard horizontal spacing unit in order to eliminate the need for separate production facilities and additional administrative applications within the Bone Spring formation. Thereby, preventing waste within Section 19 and Section 20, all while protecting the correlative rights within the referenced Horizontal Spacing Unit.

Pursuant to the authority conferred by Division Rule 19.15.16.15(B)(5) NMAC, the above-described **non-standard horizontal spacing unit is hereby approved**. Further, the Applicant may add additional wells to the horizontal spacing unit. The additional well(s) shall be designated to the same horizontal spacing unit and pool/formation.
