It is intended to recomplete the subject well in the Blanco Mesaverde (pool 72319) and downhole commingle the existing Basin Dakota (pool 71599) with the Mesaverde. The production will be commingled per Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production.

Proposed perforations are: MV - 4000' - 4560'; DK - 6453' - 6656' These perforations are in TVD.

Notification of the intent to commingle the subject well was sent to all interest owners via certified mail on 1/9/2019. An objection was received and this matter has gone to hearing. The Division has assigned an Order number R-20597.


