Dear Mr. Lowe:

Pursuant to Division Rule 19.15.15.13, Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of an unorthodox gas well location for the above captioned wells. This well will be drilled as a horizontal gas well in the Purple Sage Wolfcamp (Gas) Pool (98220).

The above well will be dedicated to a standard 640-acre gas spacing and proration unit comprising the S/2 of Section 22 and S/2 of Section 21.

The Purple Sage Wolfcamp (Gas) Pool is currently governed by Special Pool Rules, Hearing Order No. R-14262 which requires standard 320-acre gas spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit, nor closer than 10 feet to any interior quarter-quarter section line or subdivision inner boundary, or in the case of a horizontal well, no closer than 330 feet to the outer boundary of the producing area.

The unorthodox location is necessary in order to maximize the recovery of oil and gas reserves from the Wolfcamp formation underlying the S/2 of Section 22 and S/2 of Section 21.

The affected offset acreage comprises the SW/4 of Section 23, T22S- R27E NMPM (See Attached Map), which is operated by Mewbourne Oil Company.

Attached is a Form C-102 showing the surface, first take point, and bottomhole locations for the above captioned wells. Also, attached is a map showing the affected offset acreage, a horizontal well plan, and notice list.

In summary, approval of the application will provide Mewbourne Oil Company the opportunity to recover additional oil and gas reserves from the Purple Sage Wolfcamp (Gas) Pool underlying Section 21 and 22 that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.

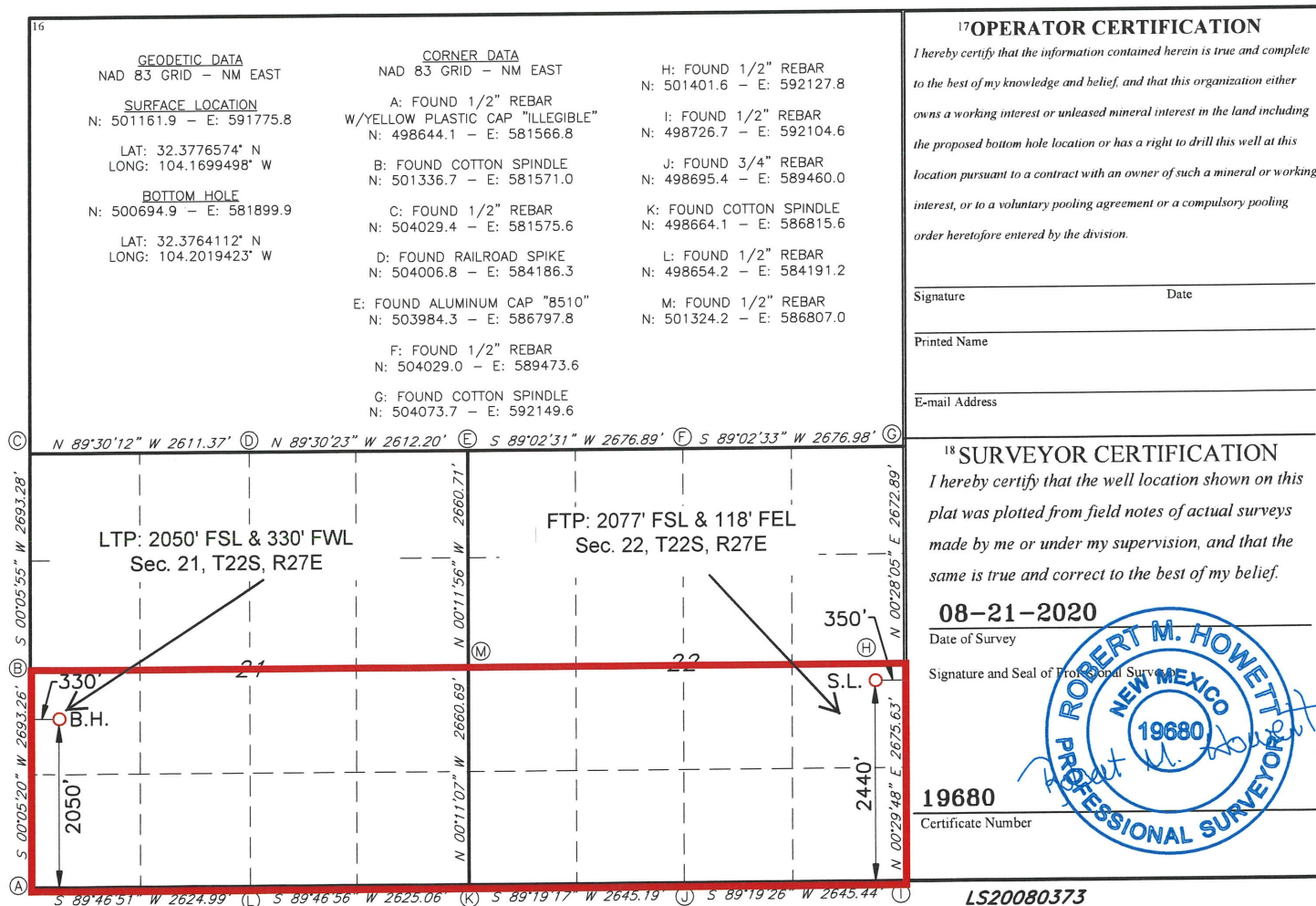

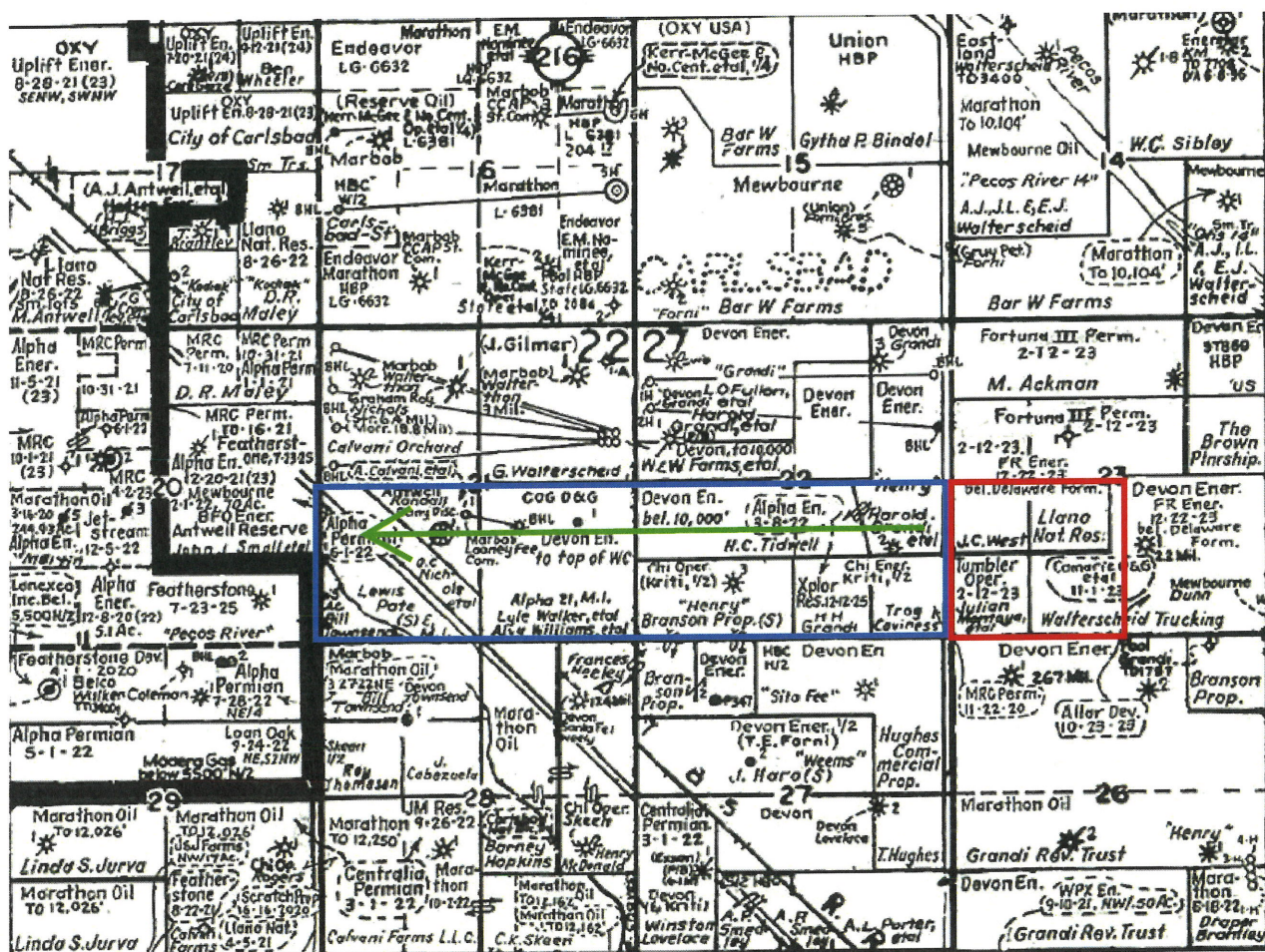
