Dear Mr. Lowe:

Pursuant to Division Rule 19.15.15.13, Mewbourne Oil Company (“Mewbourne”) respectfully requests administrative approval of an unorthodox gas well location for its proposed Salado Draw 16/9 Fed Com #808H well. This well will be drilled as a horizontal gas well in the Salado Draw; Wolfcamp, (Gas) Pool (84410).

The Salado Draw 16/9 Fed Com #808H well will be dedicated to a 640-acre gas spacing and proration unit comprising E/2 of Sections 16 & 9.

The Salado Draw; Wolfcamp (Gas) Pool is currently governed by Division Rule 19.15.15.10 which requires standard 320-acre gas spacing and proration units with wells to be located no closer than 660 feet to the outer boundary of the spacing unit, nor closer than 10 feet to any interior quarter-quarter section line or subdivision inner boundary, or in the case of a horizontal well, no closer than 660 feet to the outer boundary of the producing area.

The unorthodox location is necessary in order to maximize the recovery of oil and gas reserves from the Wolfcamp formation underlying E/2 of Sections 16 & 9.

The affected offset acreage comprises of NE/4 of Sections 21, NW/4 of Section 22, W/2 of Section 15, W/2 of Section 10, SW/4 of Section 3, and SE/4 of Section 4, T26S, R33E, NMPM (See Attached Map). Notice of this application is being provided to the attached list of parties.

Enclosed is a Form C-102 showing the surface, first take point, and bottomhole locations for the Salado Draw 16/9 Fed Com #808H well. Also, attached is a map showing the affected offset acreage, notice letter and offset notice list of parties and their addresses.

In summary, approval of the application will provide Mewbourne Oil Company the opportunity to recover additional oil and gas reserves from the Salado Draw; Wolfcamp (Gas) Pool underlying the E/2 of Sections 16 & 9 that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.

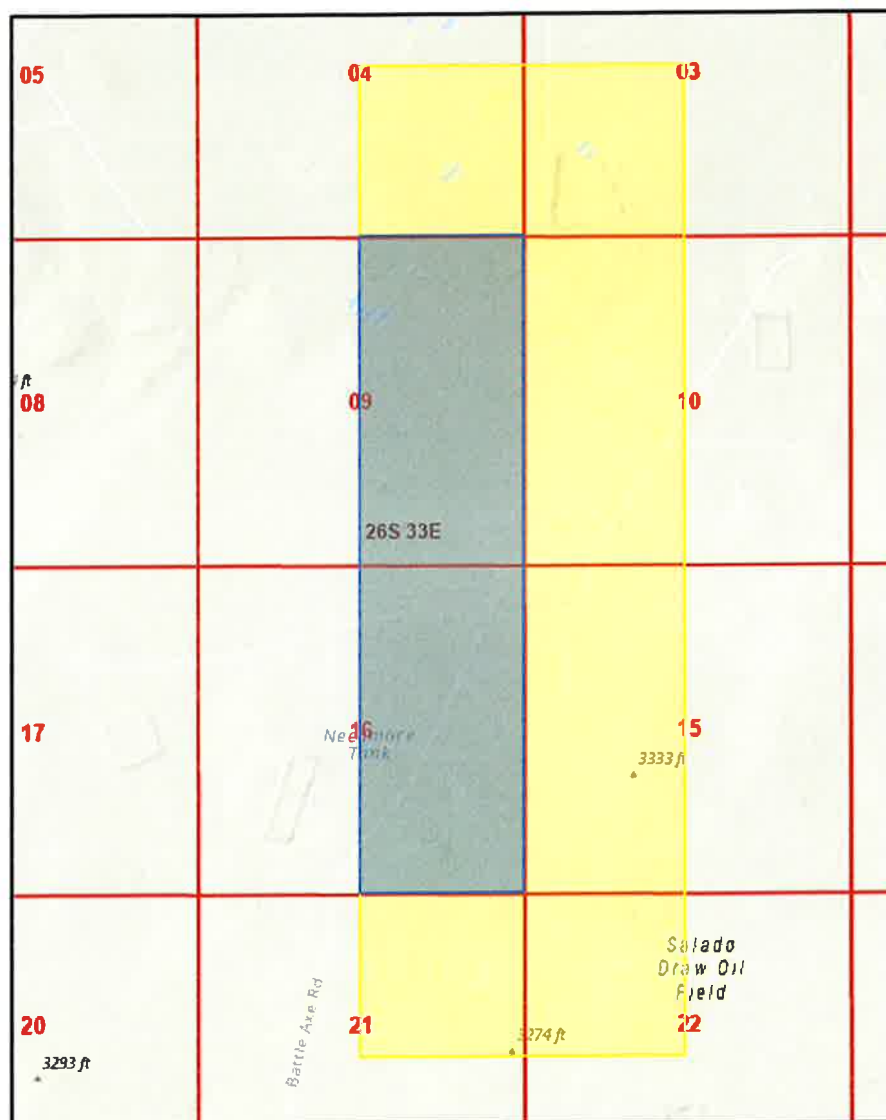
