Permian Resources Operating, LLC ("Permian") (OGRID No. 372165), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the WC-025G-06S2-3511G; Bone Spring pool (Code 96585), seeks administrative approval of an unorthodox well location for its King Eider 12 Fed Com 503H well, in a 320-acre, more or less, spacing unit underlying the W/2 E/2 of Sections 1 and 12, Township 20 South, Range 35 East, Lea County, New Mexico.

The location for the **King Eider 12 Fed Com 503H** well is as follows:

- Surface Hole Location: 170' FSL and 1005' FEL (Unit P) of Section 12
- First Take Point: 100' FSL and 2486' FEL (Unit O) of Section 12
- Last Take Point: 100' FNL and 2513' FEL (Lot 2) of Section 1
- Bottom Hole Location: 100' FNL and 2513' FEL (Lot 2) of Section 1

Since this acreage is governed by the Division's statewide rules, the completed interval for these well will be unorthodox because it is closer than the standard offset to the western boundary of the existing horizontal spacing unit. As explained in the engineering statements included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Permian to use its preferred well spacing plan for horizontal wells in this area, which will maximize recovery and prevent waste.

To Whom it May Concern,

Permian Resources Operating, LLC ("Permian") respectfully requests administrative approval on a non-standard location for the King Eider Federal Com #503H to allow the completed interval to be less than 330 feet from the western boundary of the existing 320.24-acre horizontal spacing unit. This well is located in the WC-025 G-06 S203511G, Bone Spring pool (96585). Due to the optimal spacing of the planned wells in this section, Permian has planned the King Eider Federal Com #502H, King Eider Federal Com #503H, King Eider Federal Com #504H, and King Eider Federal Com #505H wells with at least 1,080 feet of spacing between each well. This spacing pattern causes the King Eider Federal Com #503H to be drilled less than 330 feet from the western boundary of the spacing unit. Permian requests approval of this non-standard location to avoid causing wasted resources and reducing the production of the wells listed above.

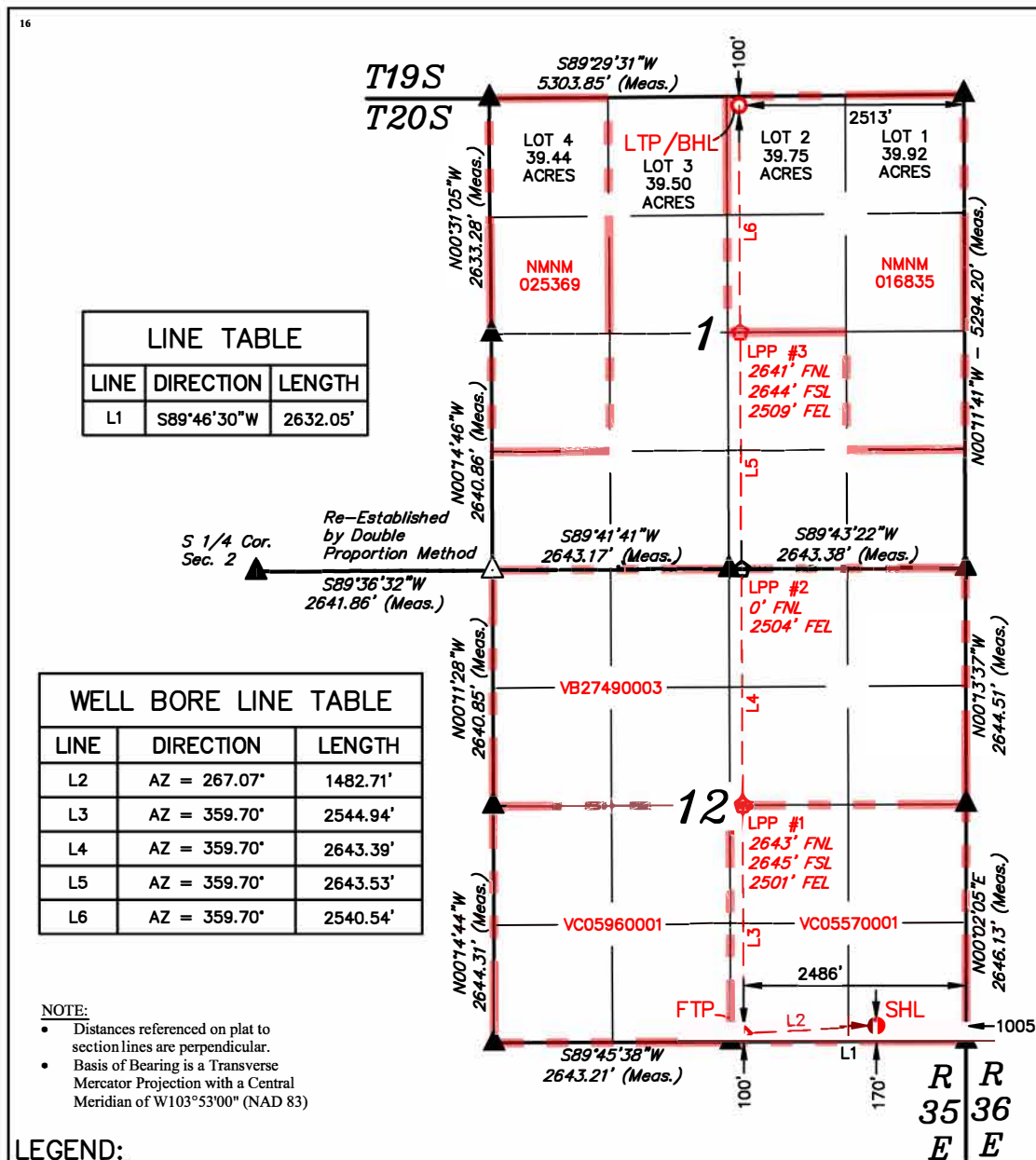

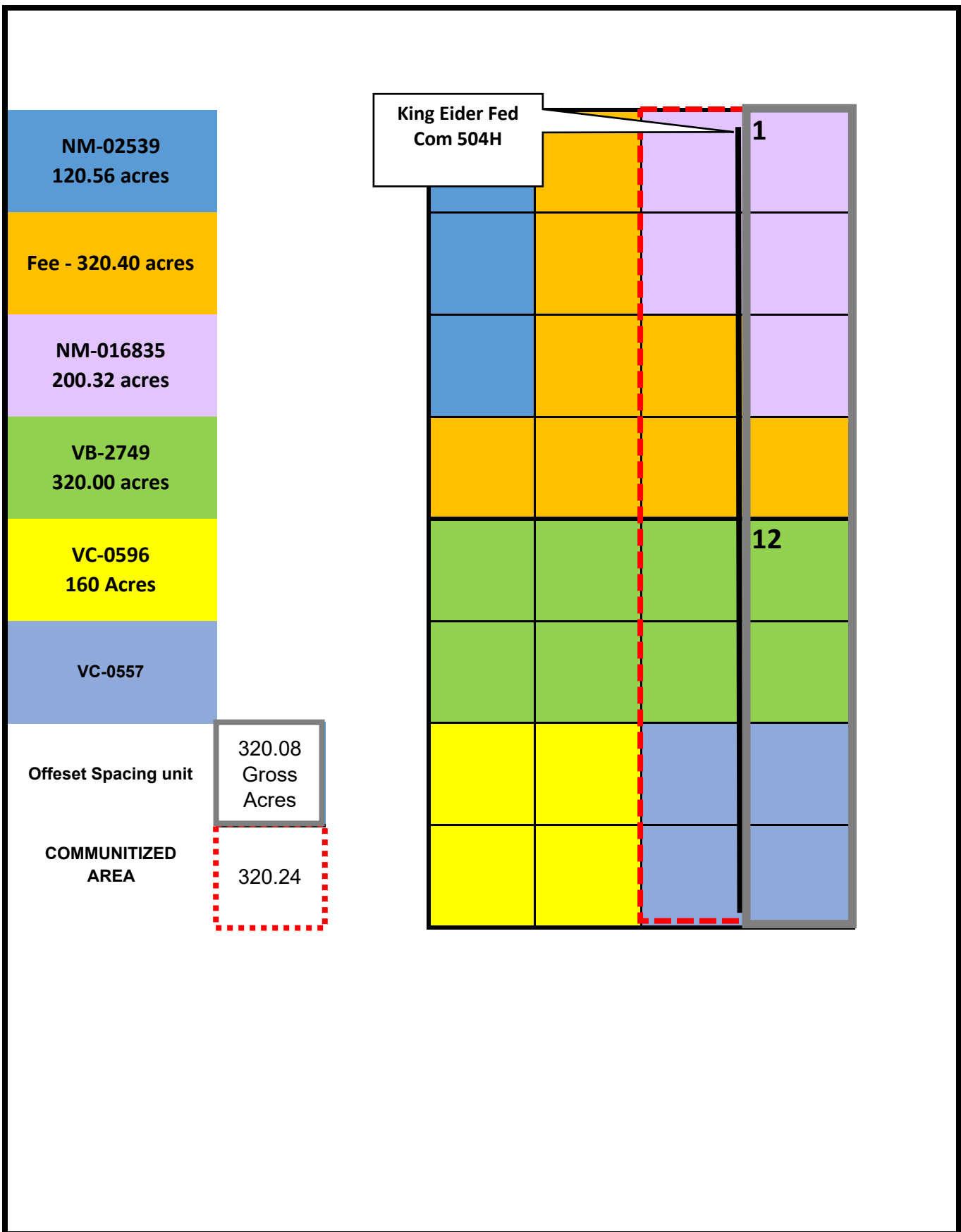
