Dear Director Fuge:

WPX Energy Permian, LLC, ("WPX"), OGRID No. 246289,, is seeking administrative approval of an unorthodox well location ("NSL") for the Horn 22-27-34 Fed Com 412H Well (the "412H Well") (API 30-015-49837) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying Sections 22, 27 and 34, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 1008' from the South line and 1194' from the East line of Section 15, Township 26 South, Range 29 East;
- Bottom Hole Location (BHL): 1895' from the North line and 930' from the East line of Section 34, Township 26 South, Range 29 East;
- First Take Point (FTP): 100' from the North line and 1130' from the East line of Section 22, Township 26 South, Range 29 East;
- Last Take Point (LTP): 1845' from the North line and 930' from the East line of Section 34, Township 26 South, Range 29 East.

WPX has included as Exhibit B a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330' foot setback requirements

("Special Rules"). The completed interval for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards (1) the E/2 S/2 of Section 15, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico to the north; and (2) the New Mexico/Texas State Line to the south. (Devon has found Mewbourne Oil Company and BPX Operating Company to be the affected parties to the south).

WPX attests that, on or before submission of this application, it provided notice to the affected persons in the adjoining E/2 S/2 of Section 15, Township 26 South, Range 29 East; and adjoining the New Mexico/Texas State Line. Said notice as described satisfies all provisions of NMAC 19.15.4.12A(2); copies of the application and required plat maps were furnished. WPX also provided notice to the Bureau of Land Management to the extent that they own interest with respect to offsetting area. WPX provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. A database search of the OCD website did not find any pooling cases associated with this application.

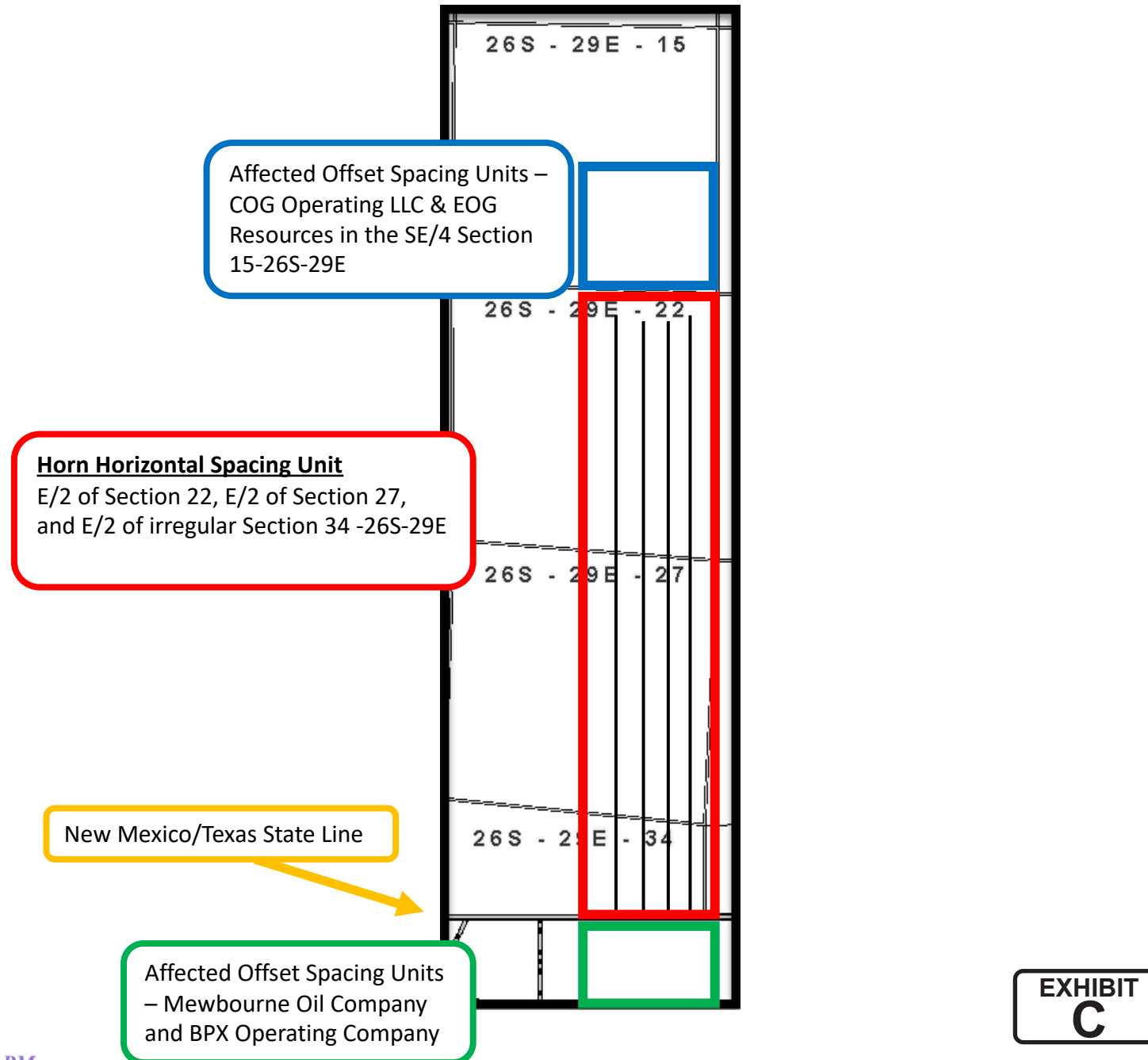
