I am following up on my phone call with you today. I am reaching out about our C108 Application/Turner #1 SWD Conversion submitted 10-28-2022. We have upcoming development in the area, and I want to follow up to see if you could give us a timeline on the approval of this application?

BTA has contracted a 3rd party SWD in the meantime to handle our water, but recently they have had issues causing BTA to have to choke off multiple wells and forcing us to truck our remaining water. We have 2 wells scheduled to flowback next week (5/29/23) in this area, and are concerned about water takeaway. We are also set to have 2 additional wells flowback next month in June, with more wells set to come on in the near future. There are limited options for water takeaway in the area, which makes this application all the more important for future development.

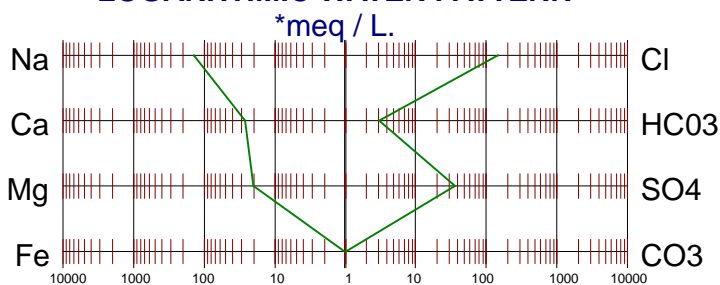
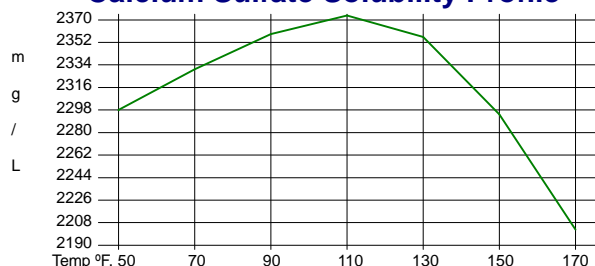

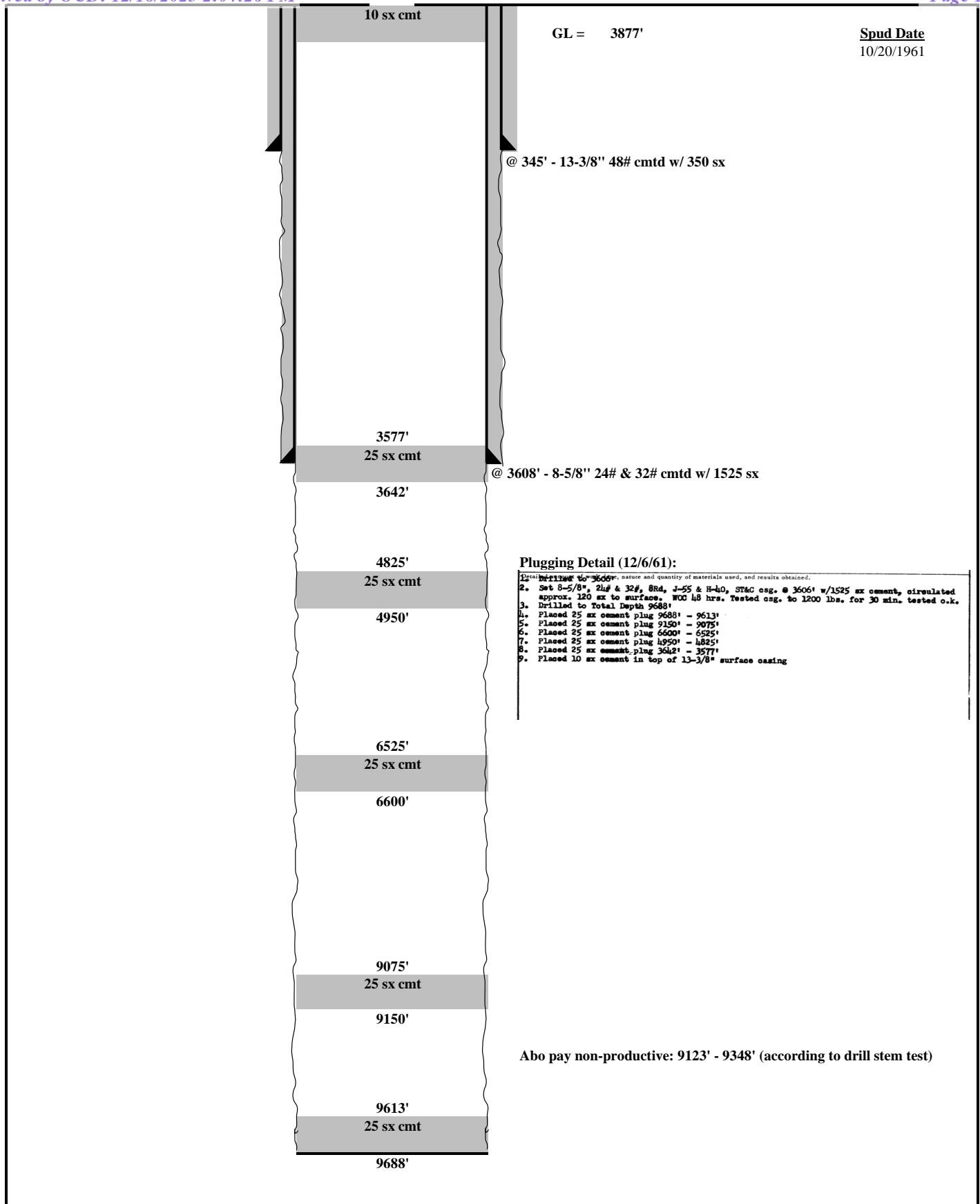
