Pending) to be completed within the Travis; Bone Spring (Oil) Pool (Pool Code 97257) underlying the S/2 of Section 33, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico. C-102s for the Wells are attached as Exhibit A. These are horizontal wells that will be drilled as follows:

# Buchanan 33 State Com 221H Well:

- Surface Location (SL): 580' from the South line and 225' from the East line of Section 33, Township 18 South, Range 28 East;
- Bottom Hole Location (BHL): 555' from the South line and 100' from the West line of Section 33, Township 18 South, Range 28 East;
- First Take Point (FTP): 555' from the South line and 100' from the East line of Section 33, Township 18 South, Range 28 East;
- Last Take Point (LTP): 555' from the South line and 100' from the West line of Section 33, Township 18 South, Range 28 East.

# Buchanan 33 State Com 222H Well:

- Surface Location (SL): 1944' from the South line and 200' from the East line of Section 33, Township 18 South, Range 28 East;




