You have requested this non-standard horizontal spacing unit in order to allow for efficient development, minimizing surface disturbance, and to allow full development of the communitized acreage within the Bone Spring formation. Thereby, preventing waste underlying Section 05, Section 08, Section 17 and Section 20 all while protecting correlative rights within the referenced Horizontal Spacing Unit.
