
Good Morning, Sarah

The C-108 application for the Lea Unit No. 10 well (SWD-2443) has been reviewed by the Division. The result of the assessment supports denial of the application for approval of injection authority by means of an administrative order. Furthermore, should the applicant decide to file for hearing of the application before either the Division or the Commission, the Engineering Bureau shall appear in opposition to approval of this application.

Denial of the application is based upon the following observations:

- 1. Well Integrity considerations:
 - a. Well was Drilled in 1963, but no record of Bradenhead tests or MIT's were found in the well file
 - b. Overall Integrity of the completion, and in particular the 7" casing, is unknown.
 - i. 7" Production casing parted at a depth of 472 feet in 1974.
 - ii. Upper portion of parted casing was recovered to surface and repaired by re-installing a 7" casing bowl and a lead (Pb) seal.
 - iii. 7" Production casing has an uncemented Annulus from 10,650 ft (Bone Springs) to the DV tool at 5530 ft (Bell Canyon).
- 2. Penetration of the Capitan Reef and associated casing /cement integrity concerns:
 - a. The 9-5/8" Intermediate casing was set across the Capitan Reef, and required multiple cementing attempts, and 13,920 sacks of cement, to achieve cement to surface.
 - b. The wellbore design from 1963 is unacceptable by current standards / best practices to facilitate protection of the Capitan Reef (i.e. classified as an Underground Source of Drinking Water (USDW) and as a Protectable Water).
 - c. Zones covered by the 9-5/8" intermediate casing include Rustler, Salado, Yates, 7-Rivers, Capitan Reef and Delaware Mountain Group. Any "disturbance" to the wellbore should be minimized /avoided with respect to pressure cycling and temperature fluctuations to mitigate the potential for annular crossflow. Considering these pre-existing wellbore conditions, approval of a SWD permit would not be prudent.
