OXY USA INC requests approval to add the following wells to PLC 750-G. These wells will be included in the currently approved pools of PIERCE CROSSING; BONESPRING, EAST, PIERCE CROSSING; BONE SPRING, and CEDAR CANYON BS and currently approved CAs (NMNM141235 and NMNM141236) in PLC 750-G.

The facilities described in PLC 750-G are unchanged – each facility has a sales-quality orifice meter (BLM gas FMP or equivalent meter) that continuously measures gas volume before it leaves the facility. Any commingling of wells upstream of these meters has been approved according to the Commingle Orders for each individual facility.

This request is for gas production only. Oil production will be handled through an amendment to PLC-660-B for Salt Flat Battery Train #3 (C-20-24S-29E) and PLC-661-B for Salt Flat Battery Train #4 (C-20-24S-29E).

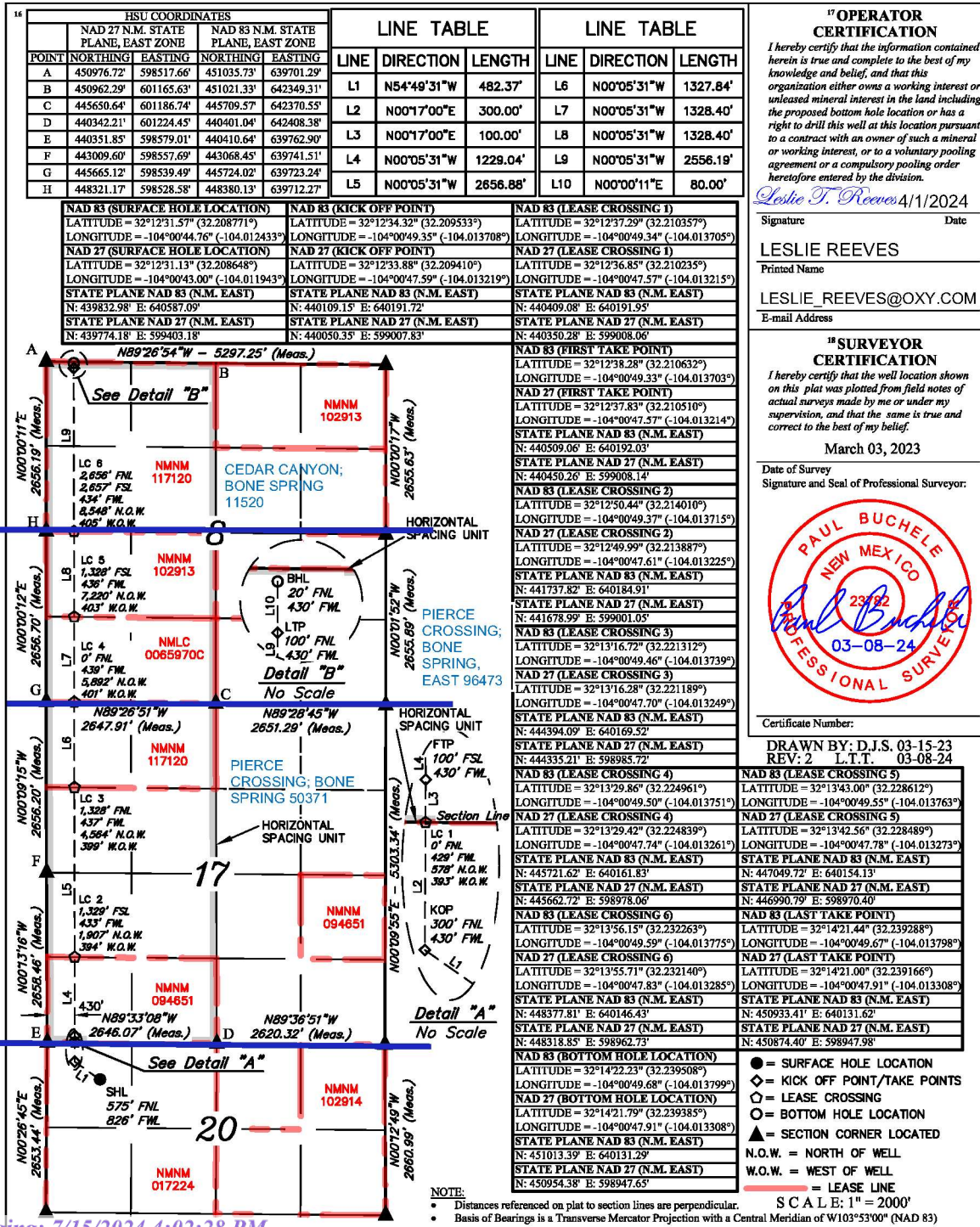

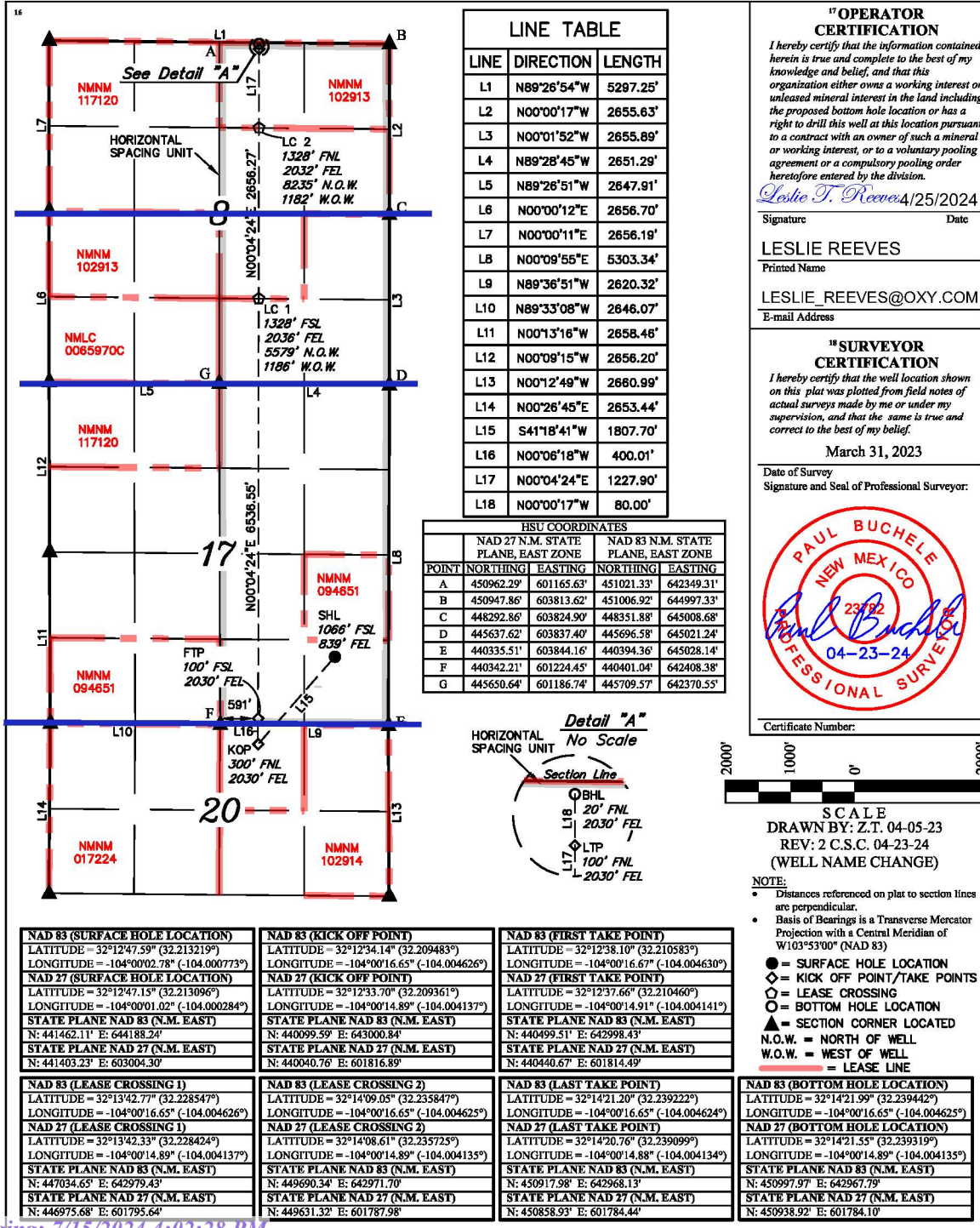

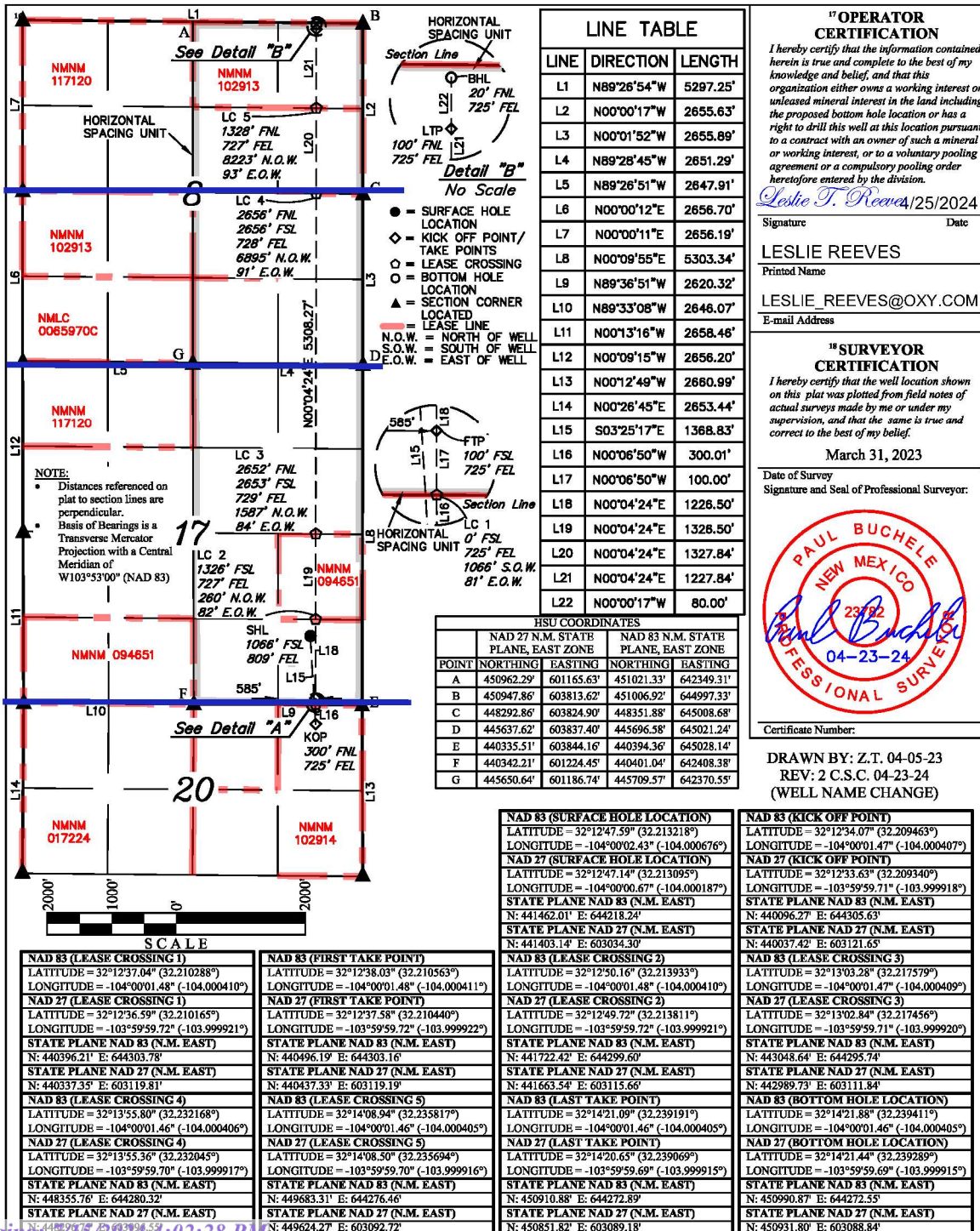
