Commingling will not reduce the value of the production. The Jicarilla Apache Tribe has been notified in writing of the intent. Proposed perforations are: Mesaverde 5246' - 6128, Mancos 6694' - 7650', Dakota 7732' - 8001'. Hilcorp will use either a spinner or compositional method to establish the allocation for the commingled well. Notification of the intent to commingle the subject well was emailed to JOGA on 7/17/2024.

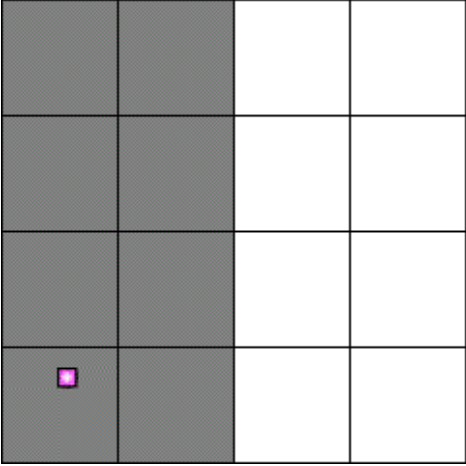

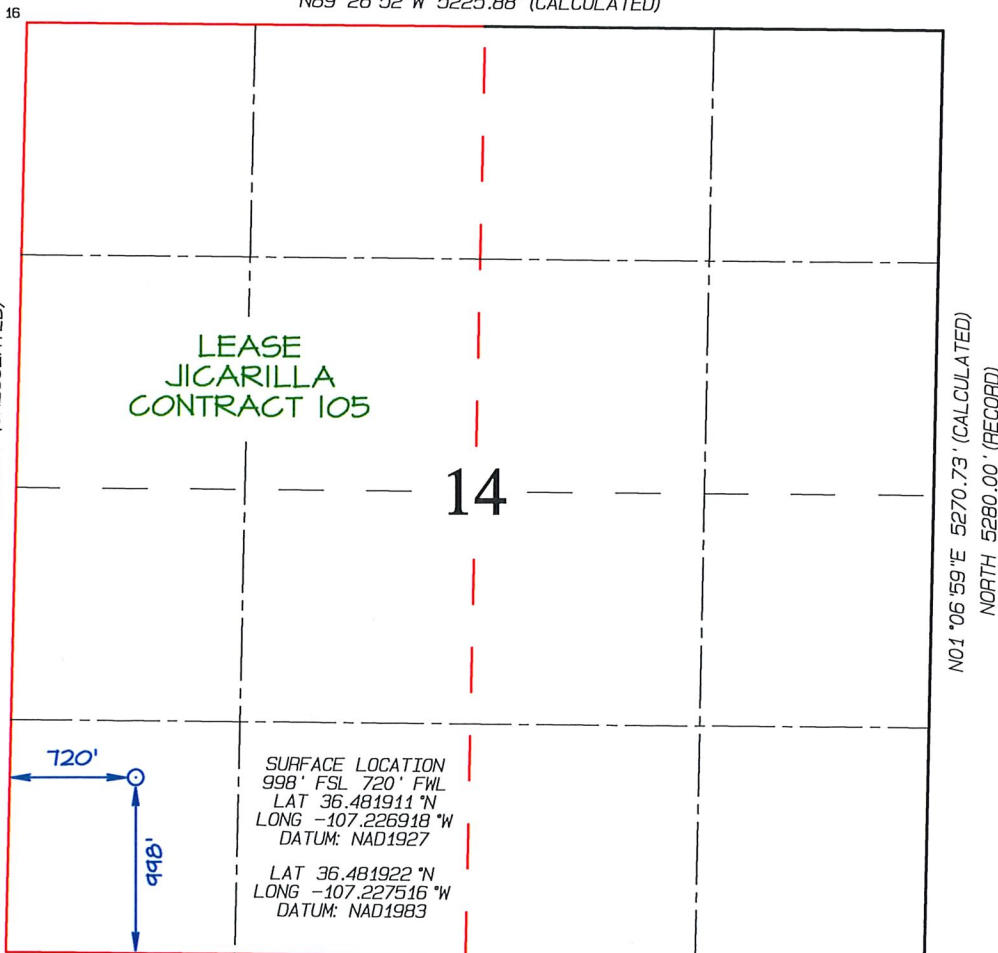
