Pursuant to Division Rule 19.15.16.15(B)(5), Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of a non-standard proration unit for its proposed DOUBLE STAMP 9/8 Fed Com #526H and the DOUBLE STAMP 9/8 Fed Com #528H wells listed above. These wells will be drilled as a horizontal oil wells in the Sand Tank; Bone Spring (Oil) pool (96832).

The DOUBLE STAMP 9/8 Fed Com #526H and the DOUBLE STAMP 9/8 Fed Com #528H wells will be dedicated to 640-acre proration unit comprising the S2 of Section 9 and the S2 of Section 8, T-18-S, R-29-E, Eddy County, New Mexico. There are currently no other existing Bone Spring Oil wells producing from within the proposed spacing unit.

The affected offset acreage comprises the E/2 of Sec. 7, the N/2 of Sec. 8, the N/2 of Sec. 9, the W/2 of Sec. 10, the NW/4 of Sec. 15, the N/2 of Sec. 16, the N/2 of Sec. 17, and the NE/4 of Sec. 18 (See attached map). All the mentioned lands are in T18S-R29E, Eddy County, New Mexico. Consequently, notice of this application is being provided to all parties listed on the attached list of affected parties.




