Dear Mr. Lowe:

Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location for the Staley 30 State Com 10H well, API Number 30-015-Pending, Property Code Pending. The 10H well is proposed to be completed in the Red Lake; Glorieta-Yeso; Northeast pool, pool code 96836.

The Staley 30 State Com 10H well will be dedicated to a 160-acre horizontal spacing unit comprising of the N2/N2 of Section 30, Township 17 South, Range 28 East.

This well will encroach towards the southern boundary of the horizontal spacing unit, but only encroaching on the SW4/NW4 (Lot 2) of Section 30, Township 17 South, Range 28 East (map attached).

Approval of the unorthodox, completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

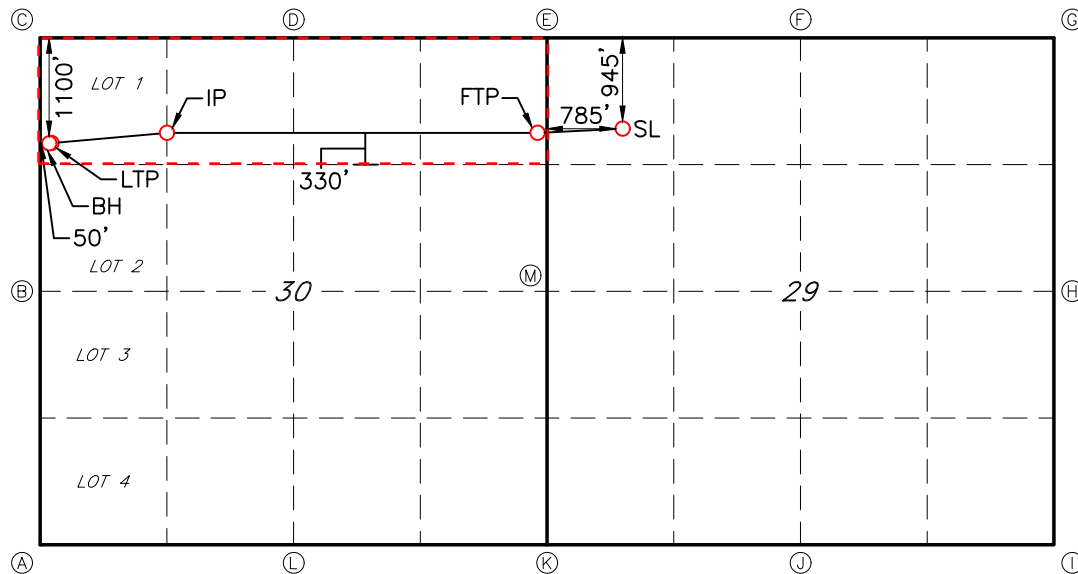
