You have requested to complete this horizontal well as a **gas** well described above in the referenced pool or formation. WPX Energy Permian, LLC ("WPX"), OGRID No. 246289, is seeking administrative approval of an unorthodox well location ("NSL") for the Steel Guitar 35-26 Fed Com 443H Well (the "443H Well") (API No. 30-015-55941) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying a standard 430.41-acre, more or less, horizontal spacing unit comprised of the W/2 of Sections 26 and 35, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

WPX has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). The special Division rules for the purple Sage; Wolfcamp Pool establish 330' foot setback requirements which are laid out in Order No. R-14262. The first and last take points for the proposed well are closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the SE/4 of Section 23 and the Southern state line of New Mexico, all in Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico.

WPX attests that, on or before submission of this application, it sent notice to the affected persons in the adjoining horizontal spacing unit which covers the SE/4 of Section 14 and the E/2 of Section 23, all in Township 26 South, Range 29 East; said notice as described satisfies all provisions of 19.15.4.12A(2) NMAC; copies of the application and required plat maps were furnished. WPX has also provided notice to the Bureau of Land Management to the extent that federal leases are involved, pursuant to 19.15.2.7A(8)(d) NMAC. 


