You have requested to complete this horizontal well as a **gas** well described above in the referenced pool or formation. This well is governed by special rules R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and governs wells to be located at least 330 feet from the unit outer boundary of a spacing unit and no closer than 10 feet to any quarter – quarter section line. The completed intervals of horizontal wells are to be located no closer than 330 feet to the exterior boundary of a standard 320 - acre **gas** spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

The well's completed interval is as close as 101 feet to the southern boundary and 100 feet to the northern boundary of the horizontal spacing unit. Encroachment will impact the following tract(s).

Section 25, encroachment to the SW/4  
Section 12, encroachment to the SW/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.

The Division understands you are seeking this unorthodox location to increase the recovery of natural resources within the Wolfcamp formation underlying the NW/4 of Section 25, the W/2 of Section 24 and the W/2 of Section 13, thereby protecting the correlative rights and the disposition of waste resulting from oil and gas operations.

Devon Energy Production Company, L.P., ("Devon"), OGRID No. 6137, is seeking administrative approval of an unorthodox well location ("NSL") for the Morgan 25-13 Fed Com 836H Well (the "836H Well") (API 30-015-55758) located in the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying a standard 800-acre, more or less, horizontal spacing unit comprised of the W/2 of Sections 13 and 24 and the NW/4 of Section 25, all in Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that has been drilled as follows:

- Surface Location (SL): 2433' from the North line and 2540' from the West line (Unit F) of Section 25, Township 25 South, Range 31 East;
- Bottom Hole Location (BHL): 20' from the North line and 1815' from the West line (Unit C) of Section 13, Township 25 South, Range 31 East;
- First Take Point (FTP): 2539' from the North line and 1815' from the West line (Unit F) of Section 25, Township 25 South, Range 31 East;
- Last Take Point (LTP): 100' from the North line and 1815' from the West line (Unit C) of Section 13, Township 25 South, Range 31 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220). Order No. 14262 requires that the first and last take points shall be no closer than a 330' distance from the outer boundary of the horizontal spacing unit.

The unorthodox location encroaches toward SW/4 of Section 12 and the N/2 SW/4 of Section 25, all in Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico.

Devon attests that, on or before submission of this application, it sent notice to the affected persons/parties in (1) the adjoining horizontal spacing unit which covers the SW/4 of Section 25 and the W/2 of Section 36; and (2) the SW/4 of Section 12, all in Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico. Devon has also provided notice to the Bureau of Land Management ("BLM") to the extent that federal leases are involved, pursuant to NMAC 19.15.2.7A(8)(d); said notice as described satisfies all provisions of NMAC 19.15.4.12A(2); copies of the application and required plat maps were furnished. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to the affected persons, is attached hereto as Exhibit D. Devon has informed us that there is no pooling case associated with this application.



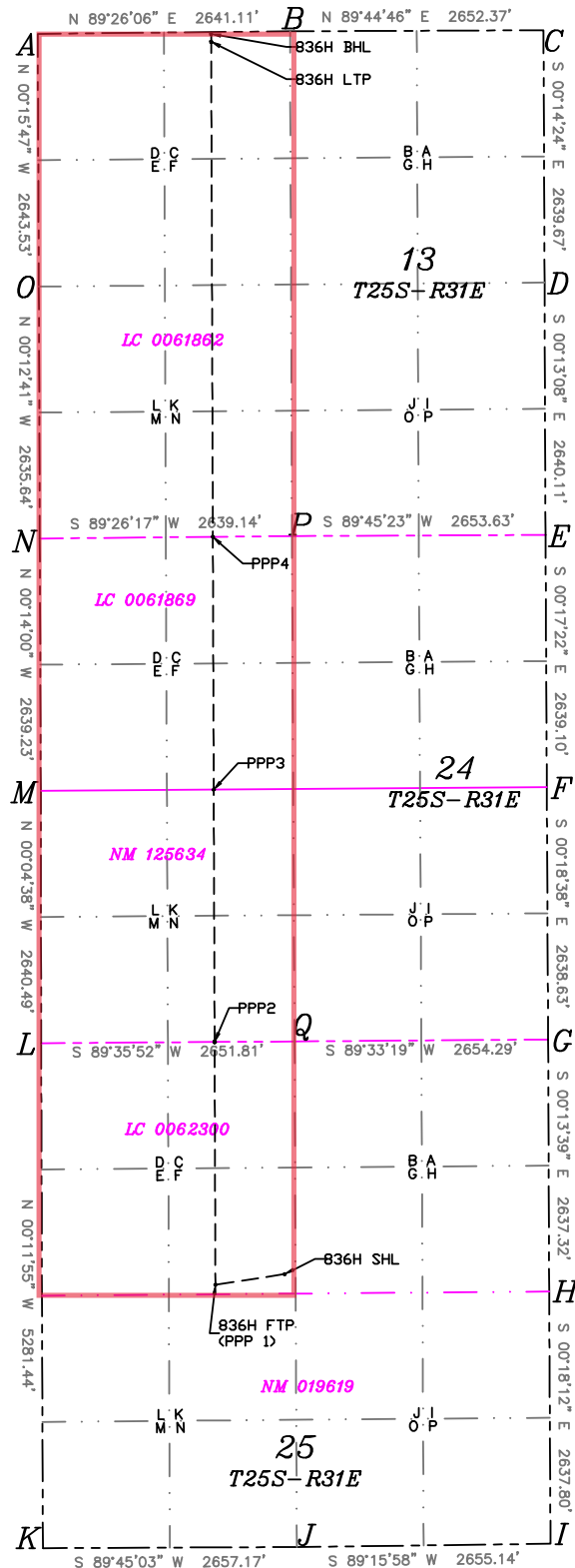

Devon Energy Production Company, L.P. respectfully requests administrative approval of a non-standard location ("NSL") for each of the Wells referenced above. The Wells are in the Purple Sage-Wolfcamp Gas Pool (Pool Code 98220). It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last take point from three hundred and thirty feet (330') to one hundred feet (100') will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.

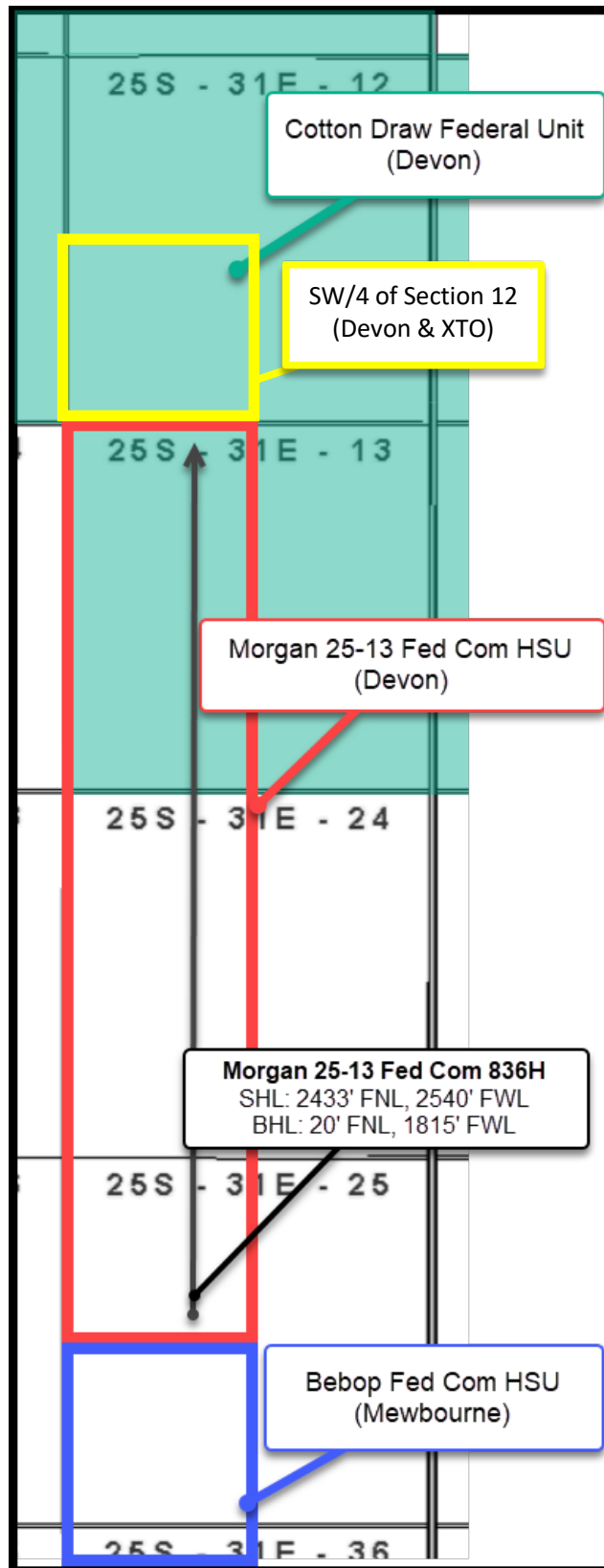
