Devon Energy Production Company, L.P., ("Devon"), OGRID No. 6137, is seeking administrative approval of an unorthodox well location ("NSL") for the Morgan 25-13 Fed Com 836H Well (the "836H Well") (API 30-015-55758) located in the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying a standard 800-acre, more or less, horizontal spacing unit comprised of the W/2 of Sections 13 and 24 and the NW/4 of Section 25, all in Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico. Order No. 14262 requires that the first and last take points shall be no closer than a 330' distance from the outer boundary of the horizontal spacing unit.

The unorthodox location encroaches toward SW/4 of Section 12 and the N/2 SW/4 of Section 25, all in Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico.






