You have requested to complete this horizontal well as a **gas** well described above in the referenced pool or formation. This well is governed by special rules R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and governs wells to be located at least 330 feet from the unit outer boundary of a spacing unit and no closer than 10 feet to any quarter – quarter section line. The completed intervals

of horizontal wells are to be located no closer than 330 feet to the exterior boundary of a standard 320 - acre **gas** spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

This well's completed interval is as close as 100 feet to the northern edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 14, encroachment to the SE/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

The Division understands you are seeking this unorthodox location to minimize reserves left in the ground and to increase the recovery of reserves within the unit. Thus, preventing waste of natural resources and protecting the correlative rights within the Wolfcamp formation underlying the E/2 of Section 35, E/2 of Section 26 and the E/2 of Section 23.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per 19.15.15.13 (B) NMAC, **Division approves this unorthodox location.**

Reference this NSL order number on the As Drilled C-102 submitted with the Authorization to Transport, to place this well into production.

WPX Energy Permian, LLC ("WPX"), OGRID No. 246289, is seeking administrative approval of an unorthodox well location ("NSL") for the Ross Draw 35-26-23 Fed Com 453H Well (the "453H Well") (API No. Pending) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying a standard 769.91-acre, more or less, horizontal spacing unit comprised of the E/2 of Sections 23, 26, and 35, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 416' from the South line and 1492' from the East line (Lot 2) of Section 35, Township 26 South, Range 30 East;
- Bottom Hole Location (BHL): 20' from the North line and 2310' from the East line (Unit B) of Section 23, Township 26 South, Range 30 East;
- First Take Point (FTP): 100' from the South line and 2310' from the East line (Lot 2) of Section 35, Township 26 South, Range 30 East;
- Last Take Point (LTP): 100' from the North line and 2310' from the East line (Unit B) of Section 23, Township 26 South, Range 30 East.

WPX has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). The special Division rules for the Purple Sage; Wolfcamp Pool establish 330' foot setback requirements which are laid out in Order No. R-14262. The first and last take points for the proposed well are closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the SE/4 of Section 14 and the southern state line of New Mexico, all in Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico.

WPX attests that, on or before submission of this application, it provided notice to the affected persons in the adjoining horizontal spacing unit which covers the S/2 of Section 11 and all of Section 14, all in Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico; said notice as described satisfies all provisions of 19.15.4.12A(2) NMAC; copies of the application and required plat maps were furnished. WPX has also provided notice to the Bureau of Land Management to the extent that federal leases are involved, pursuant to 19.15.2.7A(8)(d) NMAC. WPX provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. The pooling case associated with this application is Case No. 25153.



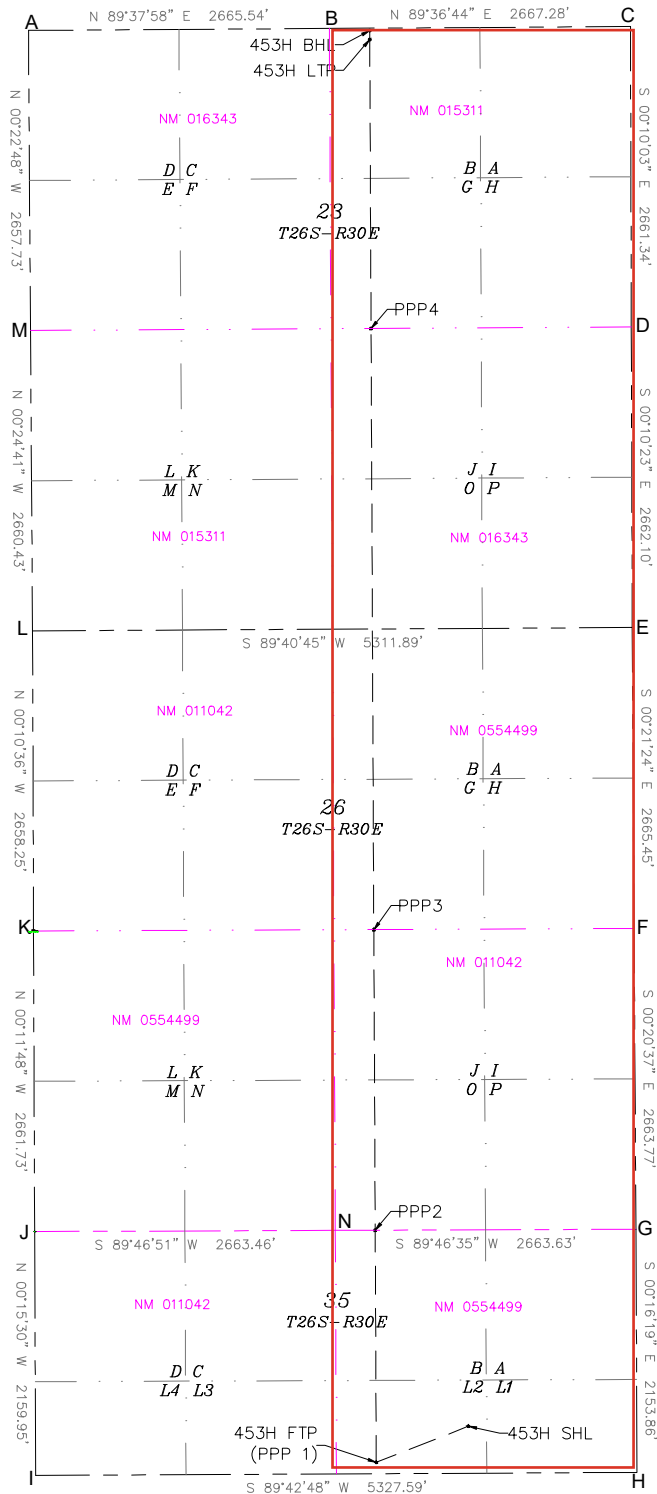

## Ross Draw 35-26-23 Fed Com 453H Affected Unit Plat

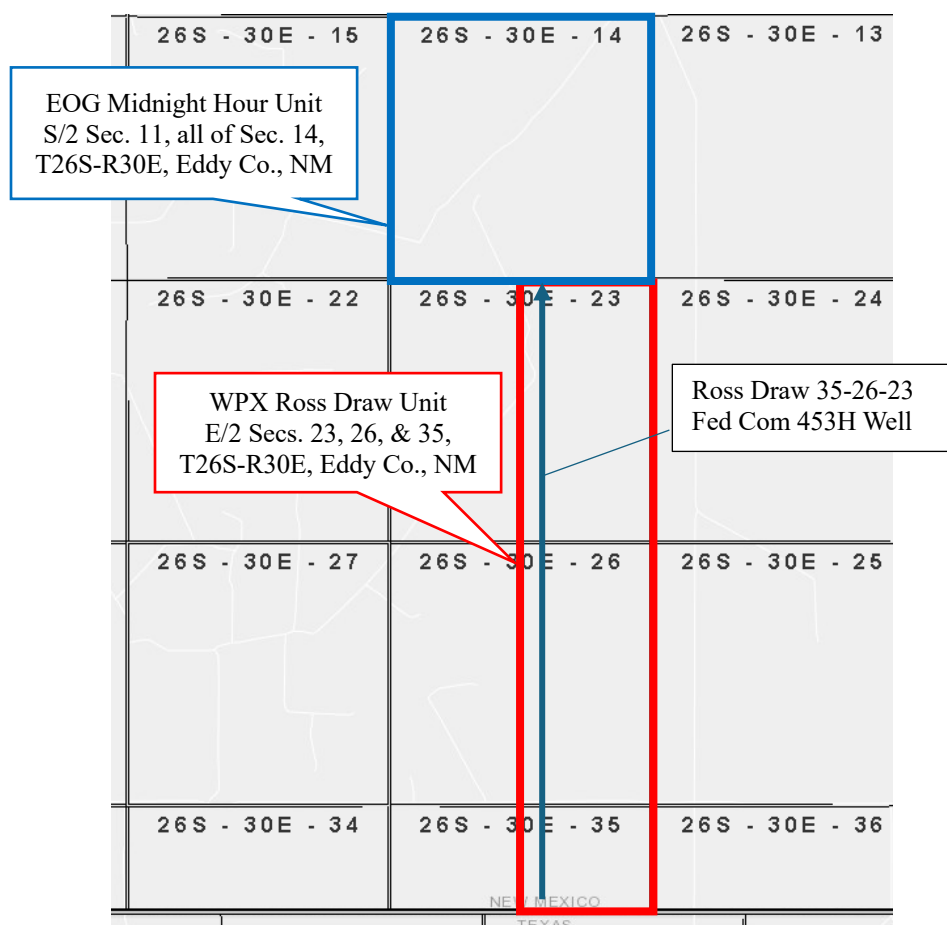
