The NSL application for the above subject well shows that notice was not done properly.

- Gas pools (Purple Sage; W.C.), the affected tracts should be noticed a total of 160 acres of the encroached area. It appears that was not
  done. Notice is lacking within your NSL application.
- The NSL application does not state where specifically notice was provided to. It only states towards the north and the south. But does not state was specific location.

The completed interval of the well will be unorthodox because it is located less than 330 from the north and south boundary line of the spacing unit. As explained in the engineering statement, included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Permian Resources to properly place stimulation energy, optimize pressure drawdown, and improve overall productivity of the wells. This will prevent waste and protect correlative rights.

The C-102 map schematic needs to show the outline of the HSU, it does not. Please indicate the HSU on the C-102

### ACREAGE DEDICATION PLATS

This grid represents a standard section. You may superimpose a non-standard section, or larger area, over this grid. Operators must outline the dedicated acreage in a red box, clearly show the well surface location and bottom hole location, if it is directionally drilled, with the dimensions from the section lines in the cardinal directions. If this is a horizontal wellbore show on this plat the location of the First Take Point and Last Take Point, and the point within the Completed interval (other than the First Take Point or Last Take Point) that is closest to any outer boundary of the tract.

- Exhibit C does not specifically state where notice was given. It only shows the leases on within the area of interest around the HSU.
- Exhibit D the "Notice List". The list does not show where the referenced names are located in accordance with the affected tracts of the NSL. It does not show what type of an Affected Party they are. It does not show when they were notified. There are no mailing tracking numbers for the Notice List.

If the other Permian Ocotillo State Com well NSL application show the same lacking information the OCD will need to cancel these applications and deny the request at this time until all is completed accordingly.
