UIC Permit SWD-2058 approved February 8, 2021.

Good afternoon, Mr. Jameson. Per your request, the C-108 applications identified as the Lucas wells will be cancelled and no further action is required. In regard to the Bounds SWD No. 1, the Director approved the UIC permit (administrative order SWD-2058) on February 8, 2021, and had an effective period of one year to commence injection or request an extension for maintaining the injection authority. However, SWD-2058 expired automatically on February 8, 2022, without either the completed well commencing injection of produced water or a written request for an extension being submitted to the OCD as stipulated in permit. Thank you for providing the information regarding these applications. PRG
